PROSPECTIVE PURCHASERS OF STATE TIMBER SALES NEED TO BE AWARE THAT THE DEPARTMENT OF FORESTRY IS ENGAGED IN AN ACTIVE THREATENED AND ENDANGERED SPECIES SURVEY PROGRAM. AS PART OF THAT PROGRAM, ODF SURVEYS ITS LANDS ON A CONTINUING BASIS FOR LAND MANAGEMENT, SPECIES PROTECTION, RESEARCH, AND OTHER REASONS. PROSPECTIVE PURCHASERS ARE REMINDED THAT ODF SURVEYING EFFORTS MAY TAKE PLACE DURING THE LIFE OF ANY TIMBER SALE CONTRACT, AND THAT THE DISCOVERY OF A THREATENED OR ENDANGERED SPECIES IN THE VICINITY OF A TIMBER SALE MAY AFFECT OPERATIONS CONTEMPLATED UNDER THE CONTRACT. THIS INCLUDES TIMBER SALES THAT HAVE BEEN DETERMINED TO BE UNSUITABLE HABITAT OR NOT DETRIMENTAL TO HABITAT. PLEASE REFER TO SECTIONS 30, 32, AND 33 OF YOUR CONTRACT PROSPECTUS, OR CONTACT OUR WILDLIFE INFORMATION COORDINATOR AT (503) 945-7374 FOR FURTHER INFORMATION.

The sale areas were surveyed for northern spotted owls in 1999 and 2000, with no observations of spotted owls. However, these surveys did not adequately cover suitable habitat around the sale area as specified in the protocol. In order to be consistent with the protocol endorsed by U.S. Fish and Wildlife Service, the sale and surrounding area are being surveyed six times in 2001. These surveys are scheduled to be complete prior to the auction date.

Since the northern spotted owl survey of the sale and surrounding area is a one-year, six visit survey, the survey results will be valid until March 15, 2002. All timber must be felled by this date.

This sale does not contain suitable habitat for marbled murrelets. Surveys for murrelets are not necessary.
