THREATENED AND ENDANGERED SPECIES INFORMATION:

This State timber sale contract requires that Purchaser comply with all laws, including the Endangered Species Act (ESA). The Department of Forestry (ODF) has surveyed the sale area shown in Exhibit "A" for northern spotted owls and marbled murrelets. Results of the surveys are on file with ODF, and are available for inspection upon request. Northern spotted owls were not detected in survey areas within or adjacent to this sale. ODF has established a Marbled Murrelet Management Area within 0.25 mile of the sale area described in Exhibit "A". Section 39 of the contract establishes certain restrictions as a result of this situation. Prospective purchasers should reference that section for restriction details. ODF will be conducting threatened or endangered species surveys in or around the sale area during the life of this contract. ODF does not guarantee that additional threatened or endangered species will not be found elsewhere within or near this sale. In the event a threatened or endangered species is found, ODF may take steps, including contract alteration or termination as provided in Section 32 of the contract, if ODF believes those steps are necessary to protect the interests of State. Purchaser should take appropriate steps to be certain that no ESA violations occur.

SPECIAL REMARKS:

#### SEASONAL RESTRICTIONS APPLY - SEE SECTION 39.

Net and gross acreage for all timber sale areas was determined by using digital orthophotos and GIS.

Area I – automark thinning with patch cuts; Area II – marked thinning unit; Areas III through VIII – automark thinning units.

Fell 73 trees within Areas II and IV through VIII to create downed wood after yarding.

Top 73 trees within Areas II and IV through VIII to create snags after yarding.

Portions of Areas I and II are within ¼ mile of a Marbled Murrelet Management Area which will require imposing seasonal restrictions.

SALE OBJECTIVES:

The objectives of this timber sale are to reduce stand densities which will enhance and maintain growth in 26- to 86-year-old conifer stands and to develop a more complex forest structure over a portion of the landscape.

PROSPECTIVE PURCHASERS OF STATE TIMBER SALES NEED TO BE AWARE THAT THE DEPARTMENT OF FORESTRY IS ENGAGED IN AN ACTIVE THREATENED AND ENDANGERED SPECIES SURVEY PROGRAM. AS PART OF THAT PROGRAM, ODF SURVEYS ITS LANDS ON A CONTINUING BASIS FOR LAND MANAGEMENT, SPECIES PROTECTION, RESEARCH, AND OTHER REASONS. PROSPECTIVE PURCHASERS ARE REMINDED THAT ODF SURVEYING EFFORTS MAY TAKE PLACE DURING THE LIFE OF ANY TIMBER SALE CONTRACT, AND THAT THE DISCOVERY OF A THREATENED OR ENDANGERED SPECIES IN THE VICINITY OF A TIMBER SALE MAY AFFECT OPERATIONS CONTEMPLATED UNDER THE CONTRACT. THIS INCLUDES TIMBER SALES THAT HAVE BEEN DETERMINED TO BE UNSUITABLE HABITAT OR NOT DETRIMENTAL TO HABITAT. PLEASE REFER TO SECTIONS 30, 32, AND 33 OF YOUR CONTRACT PROSPECTUS, OR CONTACT OUR WILDLIFE INFORMATION COORDINATOR AT (503) 945-7374 FOR FURTHER INFORMATION.

This sale was surveyed for northern spotted owls in 2001 and 2002, using a protocol endorsed by the U.S. Fish and Wildlife Service. There were no observations of northern spotted owls during any of these surveys. This sale is not affected by any known northern spotted owl activity centers. Northern spotted owl surveys will continue in and around this sale area during the life of the contract, as part of ODF's survey of other planned management activities.

Portions of this sale contain, or are contiguous with, potentially suitable marbled murrelet habitat. This habitat was surveyed in 2000, 2001 and 2002 using a protocol developed by the Pacific Seabird Group. Murrelets were observed flying below canopy in contiguous habitat during several of these surveys. ODF, in consultation with Oregon Department of Fish and Wildlife, has designated a Marbled Murrelet Management Area (MMMA) within 0.25 miles of the sale area, as a result of these observations.

Seasonal restrictions are in effect for those portions of Areas 1 and 2 that are within 0.25 miles of the MMMA. There are no other seasonal restrictions or felling deadlines associated with northern spotted owls or marbled murrelets for this sale.
