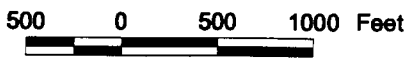

 Clatsop and Tillamook Counties, Oregon



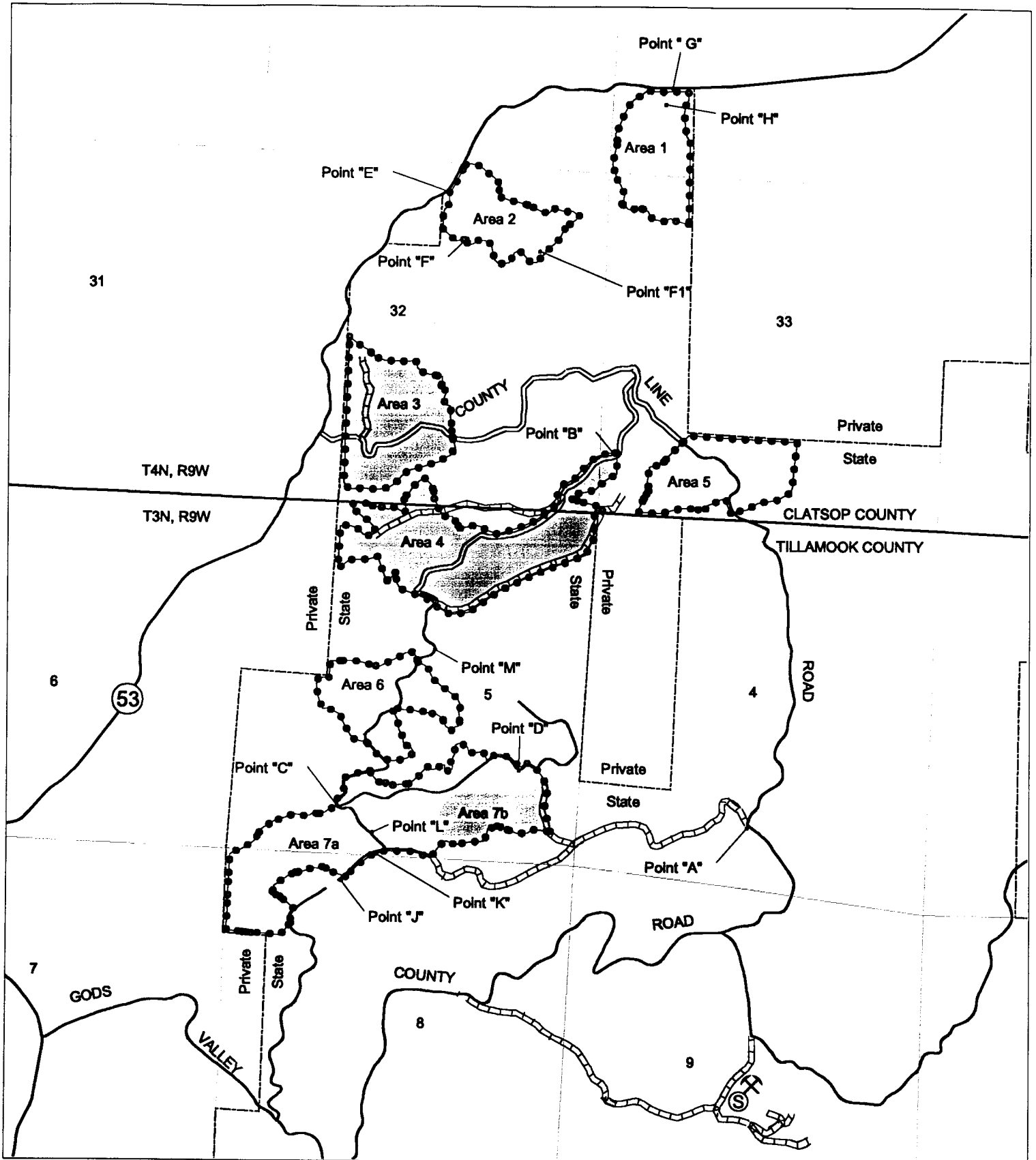
