HARVEST TYPE: 33 acres clearcut in 38-year-old Swiss Needle Cast infected Douglas-fir.

DIRECTIONS TO TIMBER SALE AREA: Approximately 15 miles south of Tillamook via Highway 101 to Bunn Road. Proceed on Bunn Road to the USFS #1004 improved road; continue on USFS #1004 approximately 1 mile from Highway 101 to Bun Creek Road, then on Bun Creek Road to the timber sale area.

As part of the survey program, ODF surveys its lands on a continuing basis for land management, species protection, research, and other reasons. SPECIAL REMARKS:	<p><b>SEASONAL RESTRICTIONS APPLY - SEE SECTION 39.</b></p> <p>Acreage was determined using GIS and digital ortho photographs.</p> <p>Purchaser is required to obtain a road use permit from the U.S. Forest Service for use of the #1004 Improved Forest Road. Estimated costs include \$143.00 for a collection agreement, \$0.675/MBF-mile for timber hauling, \$0.1168/ton-mile for aggregate haul permit fees, and a \$1.44/MBF-mile maintenance fee. Bonding and insurance is required.</p> <p>The total price for hardwoods shall be paid prior to log hauling.</p>
SALE OBJECTIVES:	Removal of Douglas-fir with severe symptoms of Swiss Needle Cast to prepare for planting with other native conifer species.

### **Habitat Suitability**

This sale does not contain potentially suitable habitat for northern spotted owls or marbled murrelets.

### **Survey Results**

Northern spotted owl and marbled murrelet surveys are not necessary for this sale.

### **Known T&E Resources**

This sale is not affected by any known northern spotted owl activity centers.

The sale is within 0.25 miles of a known occupied marbled murrelet site on USFS ownership.

### **Operational Considerations**

Seasonal operating restrictions are in effect from April 1 through September 15, annually, due to the adjacent occupied marbled murrelet habitat on USFS land. However, operations are allowed from the period of two hours after sunrise until two hours before sunset, from August 6 through September 15.

### **Future Survey Plans**

There are no future survey plans for this sale.
