HARVEST TYPE: Regeneration harvest containing approximately 51 acres of predominantly 120-year-old Douglas-fir timber.

SALE LOCATION: Portions of Sections 12 and 13, T24S, R12W, W.M., Coos County, Oregon.

DIRECTIONS TO TIMBER SALE AREA: From Coos Bay, proceed to North Bay Drive; 2.3 miles to Larson Way; 3.7 miles to the 3000 Road; then 3.8 miles to the timber sale area.

There is no project amortization. ODF will **not** reduce the price of a species to amortize the project work. Instead ODF will credit PURCHASER's timber account in the amount of \$68,522.74 after the project work is completed and accepted, as described in the section titled, "[Credit for Project Work](#)."

The timber sale areas contain negligible volumes of other logs to be paid for at the prices in Section 44.

PERFORMANCE SECURITY: 20% of bid value (unknown) **or** the total value of the project work (\$69,000), whichever is greater. Actual bond amount will be rounded up to an even \$1,000 unit.

HARVEST METHOD: 100% full suspension over the sale area when adequate deflection is available. Otherwise, single-end suspension is required.

PROJECTS: Approximately 430 feet of road construction; road widening and surfacing at Point F on the 3300 Road; construction of one landing and two rock stockpiles.

FEES: None.

ENDANGERED SPECIES ACT COMPLIANCE STATEMENT: The Oregon Department of Forestry (ODF) is engaged in an active threatened and endangered (T&E) species survey program. Surveys, determinations, and management measures are developed and implemented in good faith compliance with federal and state Endangered Species Act (ESA) requirements. Restrictions on operations due to T&E species considerations are included in the prospectus. Purchasers are required to comply with all federal and state laws, including the Endangered Species Act. Purchaser should take steps to be certain that no ESA violations occur. Prospective purchasers of timber sales are reminded that ODF surveying efforts may take place any time during the term of a timber sale contract. As part of the survey program, ODF surveys its lands on a continuing basis for land management, species protection, research, and other reasons. During the contract term, T&E survey work and/or the discovery of a threatened or endangered species within or in the vicinity of a timber sale may affect operations contemplated under the contract. In the event a threatened or endangered species is found within or near this sale, ODF may take steps necessary to protect the interests of the State, including contract alteration, suspension, or termination.

SPECIAL REMARKS: **SEASONAL RESTRICTIONS APPLY - SEE SECTION 39.**

The acreage for the timber sale was determined using orthophoto imagery on the ArcView GIS program.

Minor species within the timber sale area are reserved from harvesting.

The full purchase price for hardwoods shall be paid before log hauling.

Snag creation is required (Section 58).

Area I contains a 2-acre pocket of blowdown resulting from the February 2002 wind storm.

This sale is designed to be logged in the dry season. Purchaser must comply with the "Winter and Wet Weather Option" (Exhibit F) if operations are conducted in the winter.

SALE OBJECTIVES: The objective of the timber sale is to provide revenue for the State School Fund and to create a young age class stand in accordance with the Balanced landscape approach of the Elliott State Forest Management Plan.

Habitat Conservation Plan Area

This sale is within an area covered by a Habitat Conservation Plan (HCP) approved by the U. S. Fish and Wildlife Service. The Incidental Take Permit (ITP) for the HCP covers northern spotted owls. Under the provisions of this HCP, surveys are not required for northern spotted owls.

Habitat Suitability

This sale contains potentially suitable habitat for marbled murrelets.

Survey Results

Surveys for marbled murrelets were conducted in 2000 and 2001, using a protocol developed by the Pacific Seabird Group¹. During one survey in 2000, a single murrelet was heard from a station at Site 1. During one survey in 2000 and one survey in 2001, a single murrelet detection was recorded from a station at Site 2. There were no other marbled murrelet detections during these surveys. According to the protocol, these observations would not result in classification as an occupied site.

Known T&E Resources

This sale is not within 0.25 miles of any Marbled Murrelet Management Areas.

Operational Considerations

By ODF policy, marbled murrelet survey results are valid until April 2007. There are no seasonal operating restrictions or felling deadlines associated with marbled murrelets for this sale.

Future Survey Plans

There are no future survey plans for this sale. However, ODF will be conducting a spotted owl survey across the entire Elliott State Forest in 2003. A portion of these surveys will take place in or around the sale area.
