## **Habitat Suitability**

This sale does not contain potentially suitable habitat for northern spotted owls or marbled murrelets. There is potentially suitable marbled murrelet habitat contiguous to all sale units.

### **Survey Results**

Northern spotted owl surveys are not necessary for this sale.

Potentially suitable habitat contiguous to Area 1 was not surveyed for marbled murrelets. This habitat is adjacent to known occupied habitat on adjacent ownerships and is assumed to be occupied. Surveys for marbled murrelets were conducted for Area 2 in 2001 and 2002, using a protocol developed by the Pacific Seabird Group<sup>1</sup>. ODF conducted additional surveys concurrently with the survey contractor to enhance the survey effort. These surveys resulted in designation of an occupied stand on other ownership.

#### **Known T&E Resources**

There are no known northern spotted owl activity centers within 1.5 miles of this sale.

Although not surveyed, potentially suitable habitat contiguous to Area 1 is assumed to be occupied by marbled murrelets. Within 0.25 miles of Area 2, there is a marbled murrelet-occupied stand on other ownership.

Seasonal operating restrictions will apply from April 1 through August 5, annually to Area 2.
