HARVEST TYPE: **Areas 1 and 3:** 144 acres of “automark” partial cut commercial thinning of primarily moderate-sized Douglas-fir, ranging between 40 and 56 years old. Volume to be removed in Areas 1 and 3 is approximately 11.8 MBF/acre. **Area 2:** 40 acres of clearcut of 40- to 56-year-old primarily Douglas-fir and hemlock, with a small patch (3 acres) of 33-year-old conifer. Volume to be removed in Area 2 is approximately 26.1 MBF/acre. **Area 4 (sale access R/W):** There are 6 acres of sale access R/W consisting primarily of Douglas-fir, with a small amount of western hemlock and red alder. Volume to be removed in Area 4 is approximately 32.8 MBF/acre.

SALE LOCATION: The sale areas are located in portions of Sections 1, 2, 11, and 16, T4N, R7W, W.M., Clatsop County, Oregon.

DIRECTIONS TO TIMBER
SALE AREA: Areas 1 through 3 can be accessed via Highway 26 between Milepost 22 and 23; turn east on Osweg Creek Road and proceed up this road approximately 1.3 miles. You are now at the western sale boundary of Area 1.

There is no project amortization. ODF will **not** reduce the price of a species to amortize the project work. Instead ODF will credit PURCHASER's timber account in the amount of \$112,869 after the project work is completed and accepted, as described in the section titled, "Credit for Project Work."

The timber sale areas contain negligible volumes of other logs to be paid for at the prices in Section 44.

PERFORMANCE SECURITY: 20% of bid value (unknown) **or** the total value of the project work (\$113,000), whichever is greater. Actual bond amount will be rounded up to an even \$1,000 unit.

PROJECTS: Project No. 1: Approximately 1.18 miles of new road construction, 2.58 miles of road improvement, and landing construction. Project No. 2: Fishhawk Creek Bridge vacating and stream enhancement. Project No. 3: Approximately 18.45 miles of roadside brushing.

FEES: None.

ENDANGERED SPECIES ACT COMPLIANCE STATEMENT: The Oregon Department of Forestry (ODF) is engaged in an active threatened and endangered (T&E) species survey program. Surveys, determinations, and management measures are developed and implemented in good faith compliance with federal and state Endangered Species Act (ESA) requirements. Restrictions on operations due to T&E species considerations are included in the prospectus. Purchasers are required to comply with all federal and state laws, including the Endangered Species Act. Purchaser should take steps to be certain that no ESA violations occur. Prospective purchasers of timber sales are reminded that ODF surveying efforts may take place any time during the term of a timber sale contract. As part of the survey program, ODF surveys its lands on a continuing basis for land management, species protection, research, and other reasons. During the contract term, T&E survey work and/or the discovery of a threatened or endangered species within or in the vicinity of a timber sale may affect operations contemplated under the contract. In the event a threatened or endangered species is found within or near this sale, ODF may take steps necessary to protect the interests of the State, including contract alteration, suspension, or termination.

Project Nos. 1, 2, and 3 must be completed prior to September 30, 2004.

Timber sale acreage was determined by mapping sale areas on an ortho photograph and using ArcView to calculate acres.

SALE OBJECTIVES:

This sale is aligned with the objectives of the NWO Forest Management Plan. The Plan presents guiding principles, a forest vision, and resource management goals.

Guiding Principles (in part) – To secure the greatest permanent value of these lands to the state, the State Forester shall maintain these lands as forest lands and actively manage them in a sound environmental manner to provide sustainable timber harvest and revenues to the state, counties, and local taxing districts. This management focus is not exclusive of other forest resources but must be pursued within a broader management context.

The information shown on the Exhibit "A" map(s) are approximate locations. Exact locations of features represented by map symbols shall be determined on site and shall depend upon the conditions that exist on site. Activities shall be conducted based upon features determined on site rather than features shown on maps.

Habitat Suitability

This sale contains suitable habitat for northern spotted owls. It does not contain suitable habitat for marbled murrelets.

Survey Results

This sale was surveyed for northern spotted owls in 2002 and 2003, using a protocol endorsed by the U.S. Fish and Wildlife Service¹. There was one observation of a female northern spotted owl within 1.5 miles of the sale in 2003. Additional visits produced no further owl responses, and the observation was attributed to a known activity center greater than 1.5 miles from the sale.

Surveys for marbled murrelets are not necessary.

Known T&E Resources

There are no known northern spotted owl activity centers within 1.5 miles or Marbled Murrelet Management Areas within 0.25 miles of this sale.

Operational Considerations

Northern spotted owl survey results are valid until March 15, 2006. The contract expiration date is within the valid survey duration.

Future Survey Plans

ODF has no plans for further survey of these sales. However, ODF has an active survey program and northern spotted owl surveys will be conducted within 3 miles of this sale during the life of the contract.
