HARVEST TYPE: This is an autemark thinning sale of approximately 148 net acres of 31- to 46-year-old second growth Douglas-fir.

SALE LOCATION: The timber sale is located in portions of Sections 8, 9, 15, and 16, T24S, R11W, W.M., Coos County, Oregon.

DIRECTIONS TO TIMBER SALE AREA: From Allegany, take the West Fork Millicoma River Road (CR-47) to the 2000 Road. Area 1 is 3 miles north on the 2000 Road, off the 2090 Road. Area 2 is accessible by crossing the West Fork Millicoma River approximately 3 miles northeast of the 2000 Road turnoff on the Millicoma County Road. Look for the sign at the low-water crossing location.

There is no project amortization. ODF will **not** reduce the price of a species to amortize the project work. Instead ODF will credit PURCHASER's timber account in the amount of \$18,329.18 after the project work is completed and accepted, as described in the section titled, "Credit for Project Work."

The timber sale areas contain negligible volumes of other logs to be paid for at the prices in Section 44.

PERFORMANCE SECURITY: 20% of bid value (unknown) **or** the total value of the project work (\$19,000), whichever is greater. Actual bond amount will be rounded up to an even \$1,000 unit.

HARVEST METHOD: The majority of the sale will be cable logged uphill. Portions of Area 2 under 30% slope will be tractor loggable. Areas 1 and 2 will have seasonal restrictions and daily timing restrictions on logging.

PROJECTS: Projects include building a low-water crossing over the West Fork Millicoma River and road improvement.

FEES: \$100 fee paid to the Coos County Road Department.

ENDANGERED SPECIES ACT COMPLIANCE STATEMENT: The Oregon Department of Forestry (ODF) is engaged in an active threatened and endangered (T&E) species survey program. Surveys, determinations, and management measures are developed and implemented in good faith compliance with federal and state Endangered Species Act (ESA) requirements. Restrictions on operations due to T&E species considerations are included in the prospectus. Purchasers are required to comply with all federal and state laws, including the Endangered Species Act. Purchaser should take steps to be certain that no ESA violations occur. Prospective purchasers of timber sales are reminded that ODF surveying efforts may take place any time during the term of a timber sale contract. As part of the survey program, ODF surveys its lands on a continuing basis for land management, species protection, research, and other reasons. During the contract term, T&E survey work and/or the discovery of a threatened or endangered species within or in the vicinity of a timber sale may affect operations contemplated under the contract. In the event a threatened or endangered species is found within or near this sale, ODF may take steps necessary to protect the interests of the State, including contract alteration, suspension, or termination.

SPECIAL REMARKS: **SEASONAL RESTRICTIONS APPLY - SEE SECTION 39.**

Acreage was determined by orthophotos using ArcView GIS software.

Any conifer log having a gross scaling diameter of less than 5 inches shall be pencil bucked for the purpose of determining volume (Section 47).

SALE OBJECTIVES: Release 35- to 50-year-old plantations and naturally regenerated conifer to provide improved growing conditions, and improve habitat quality by allowing more light for understory vegetation.

The information shown on the Exhibit "A" map(s) are approximate locations. Exact locations of features represented by map symbols shall be determined on site and shall depend upon the conditions that exist on site. Activities shall be conducted based upon features determined on site rather than features shown on maps.

Habitat Conservation Plan Area

This sale is within an area covered by a Habitat Conservation Plan (HCP) approved by the U. S. Fish and Wildlife Service. The Incidental Take Permit (ITP) for the HCP covers northern spotted owls. Under the provisions of this HCP, surveys are not required for northern spotted owls.

Habitat Suitability

This sale does not contain potentially suitable habitat for marbled murrelets.

Survey Results

Surveys for marbled murrelets are not necessary.

Known T&E Resources

Portions of this sale are within 0.25 miles of Marbled Murrelet Management Areas (MMMA).

Operational Considerations

Seasonal operating restrictions are required for portions of the sale area with 0.25 miles of a MMMA, as well as for some areas of the sale that are adjacent to unsurveyed murrelet habitat as discussed in the field. Restrictions apply from April 1 through September 15 annually. Operations may be allowed from two hours after sunrise until two hours before sunset, between August 6 and September 15.

Future Survey Plans

There are no future survey plans for this sale. ODF will be conducting a spotted owl survey across the entire Elliott State Forest in 2003, however. A portion of these surveys will take place in or around the sale area.
