HARVEST TYPE: This sale is a regeneration harvest containing approximately 71 net acres of predominantly 100-year-old Douglas-fir timber.

SALE LOCATION: The timber sale area is located in portions of Section 18, T24S, R11W, W.M., Coos County, Oregon.

DIRECTIONS TO TIMBER SALE AREA: From Coos Bay, proceed north on Highway 101 to Haynes Way. Follow Haynes Way for about 2 miles to Larson Way. Take Larson Way for about 4 miles to the 3000 Road, and then proceed for 6½ miles to the 3440 Road, which is at Project Point A.

The Oregon Department of Forestry (ODF) is engaged in an active threatened and endangered (T&E) species survey program. Surveys, determinations, and management measures are developed and implemented in good faith compliance with federal and state Endangered Species Act (ESA) requirements. Restrictions on operations due to T&E species considerations are included in the prospectus. Purchasers are required to comply with all federal and state laws, including the Endangered Species Act. Purchaser should take steps to be certain that no ESA violations occur. Prospective purchasers of timber sales are reminded that ODF surveying efforts may take place any time during the term of a timber sale contract. As part of the survey program, ODF surveys its lands on a continuing basis for land management, species protection, research, and other reasons. During the contract term, T&E survey work and/or the discovery of a threatened or endangered species within or in the vicinity of a timber sale may affect operations contemplated under the contract. In the event a threatened or endangered species is found within or near this sale, ODF may take steps necessary to protect the interests of the State, including contract alteration, suspension, or termination.

The objective of this sale is to create a young age class stand in accordance with the Balanced Landscape Strategy of the Elliott State Forest Management Plan.

Habitat Conservation Plan Area

This sale is within an area covered by a Habitat Conservation Plan (HCP) approved by the U. S. Fish and Wildlife Service. The Incidental Take Permit (ITP) for the HCP covers northern spotted owls. Under the provisions of this HCP, surveys are not required for northern spotted owls.

Habitat Suitability

This sale contains potential habitat for marbled murrelets.

Survey Results

Surveys for marbled murrelets were conducted in 2002 and 2003, using a protocol developed by the Pacific Seabird Group¹. Marbled murrelets were heard during one survey visit in 2002 and one survey visit in 2003. No subcanopy behaviors were observed during any of these surveys.

Known T&E Resources

There are no Marbled Murrelet Management Areas within 0.25 miles of this sale.
