HARVEST TYPE: Autemark commercial thinning harvest containing 303 net acres of 35- to 73-year-old Douglas-fir timber.

SALE LOCATION: Section 1, T12S, R8W, W.M., Lincoln County, Oregon.

DIRECTIONS TO TIMBER
SALE AREA: From Philomath, proceed west on Highway 20 for 16 miles to Burnt Woods; turn left onto the Harlan-Burnt Woods Road; travel south for less than 1 mile, then turn left (east) onto Shotpouch County Road; continue on Shotpouch Road for 4 miles to Point B. **Access to the timber sale is through a locked yellow gate on the left. There is another locked gate farther in the sale area. A gate key can be checked out at the Philomath District Office.**

There is no project amortization. ODF will **not** reduce the price of a species to amortize the project work. Instead ODF will credit PURCHASER's timber account in the amount of \$109,189 after the project work is completed and accepted, as described in the section titled, "Credit for Project Work."

The timber sale areas contain negligible volumes of other logs to be paid for at the prices in Section 44.

PERFORMANCE SECURITY: 20% of bid value (unknown) **or** the total value of the project work (\$110,000), whichever is greater. Actual bond amount will be rounded up to an even \$1,000 unit.

HARVEST METHOD: A combination of ground-based yarding (approximately 59%) and cable yarding (approximately 41%) by volume.

PROJECTS: Projects will include road construction (1.1 miles), road improvement (3.5 miles), road brushing (2.8 miles), culvert removal work, and post-harvest activities.

FEES: None.

ENDANGERED SPECIES ACT COMPLIANCE STATEMENT: The Oregon Department of Forestry (ODF) is engaged in an active threatened and endangered (T&E) species survey program. Surveys, determinations, and management measures are developed and implemented in good faith compliance with federal and state Endangered Species Act (ESA) requirements. Restrictions on operations due to T&E species considerations are included in the prospectus. Purchasers are required to comply with all federal and state laws, including the Endangered Species Act. Purchaser should take steps to be certain that no ESA violations occur. Prospective purchasers of timber sales are reminded that ODF surveying efforts may take place any time during the term of a timber sale contract. As part of the survey program, ODF surveys its lands on a continuing basis for land management, species protection, research, and other reasons. During the contract term, T&E survey work and/or the discovery of a threatened or endangered species within or in the vicinity of a timber sale may affect operations contemplated under the contract. In the event a threatened or endangered species is found within or near this sale, ODF may take steps necessary to protect the interests of the State, including contract alteration, suspension, or termination.

SPECIAL REMARKS: **SEASONAL RESTRICTIONS APPLY - SEE SECTION 39.**

- Net and gross acreage for all timber sale areas was determined using digital orthophotos and GIS.
- All 5 sale areas are automark thinning units.
- Top 125 trees in Areas II and V for snag creation.
- Fell 125 trees in Areas II and V for down wood creation.
- Private R/W timber shall be decked along the right-of-way.
- There are 2 Type D streams that supply water for downstream residences within the timber sale area.
- **There are 2 locked gates that control access into the sale areas. A key can be checked out at the ODF Philomath Office.**

SALE OBJECTIVES: The objectives of this timber sale are to reduce stand densities to enhance and maintain growth of 35- to 73-year-old conifer stands and to develop a more complex forest structure over a portion of the landscape.

The information shown on the Exhibit "A" map(s) are approximate locations. Exact locations of features represented by map symbols shall be determined on site and shall depend upon the conditions that exist on site. Activities shall be conducted based upon features determined on site rather than features shown on maps.

Habitat Suitability

This sale contains suitable habitat for northern spotted owls and potential habitat for marbled murrelets.

Survey Results

This sale was surveyed for northern spotted owls in 2003 and 2004, using a protocol endorsed by the U.S. Fish and Wildlife Service¹. There were no observations of northern spotted owls during any of these surveys.

Surveys for marbled murrelets were conducted in 2002 and 2003, using a protocol developed by the Pacific Seabird Group^{2,3}. There were no observations of marbled murrelets during any of these surveys.

Known T&E Resources

There are no known northern spotted owl activity centers within 1.5 miles or Marbled Murrelet Management Areas within 0.25 miles of this sale.

Operational Considerations

Northern spotted owl survey results are valid until March 15, 2007. Marbled murrelet survey results are valid until April 2009.

All timber should be felled by March 15, 2007.

Future Survey Plans

ODF has no plans for further survey of this sale. However, ODF has an active survey program and northern spotted owl surveys will be conducted within 3 miles of this sale during the life of the contract.
