HARVEST TYPE: This sale is a regeneration harvest containing 70 net acres of predominantly 38-year-old Douglas-fir timber.

SALE LOCATION: Portions of Sections 25 and 36, T23S, R11W, and Section 30, T23S, R10W, W.M., Coos County, Oregon.

DIRECTIONS TO TIMBER SALE AREA: From Coos Bay, proceed east on Coos River Highway for 14 miles, then proceed on State Forest 1000 Road for 10.5 miles to the 9000 Road. Travel on the 9000 Road for about 2.5 miles to Project Point A.

There is no project amortization. ODF will **not** reduce the price of a species to amortize the project work. Instead ODF will credit PURCHASER's timber account in the amount of \$24,002 after the project work is completed and accepted, as described in the section titled, "Credit for Project Work."

The timber sale areas contain negligible volumes of other logs to be paid for at the prices in Section 44.

PERFORMANCE SECURITY: 20% of bid value (unknown) **or** the total value of the project work (\$25,000), whichever is greater. Actual bond amount will be rounded up to an even \$1,000 unit.

ENDANGERED SPECIES ACT COMPLIANCE STATEMENT: The Oregon Department of Forestry (ODF) is engaged in an active threatened and endangered (T&E) species survey program. Surveys, determinations, and management measures are developed and implemented in good faith compliance with federal and state Endangered Species Act (ESA) requirements. Restrictions on operations due to T&E species considerations are included in the prospectus. Purchasers are required to comply with all federal and state laws, including the Endangered Species Act. Purchaser should take steps to be certain that no ESA violations occur. Prospective purchasers of timber sales are reminded that ODF surveying efforts may take place any time during the term of a timber sale contract. As part of the survey program, ODF surveys its lands on a continuing basis for land management, species protection, research, and other reasons. During the contract term, T&E survey work and/or the discovery of a threatened or endangered species within or in the vicinity of a timber sale may affect operations contemplated under the contract. In the event a threatened or endangered species is found within or near this sale, ODF may take steps necessary to protect the interests of the State, including contract alteration, suspension, or termination.

- Snag creation is required (Section 58).
- Log placement into tributaries of Elk Creek is required (Section 63) as specified in Exhibit H.

SALE OBJECTIVES: The objective of this timber sale is to create a young age class stand in accordance with the Balanced Landscape Strategy of the Elliot State Forest Management Plan.

Habitat Conservation Plan Area

This sale is within an area covered by a Habitat Conservation Plan (HCP) approved by the U. S. Fish and Wildlife Service. The Incidental Take Permit (ITP) for the HCP covers northern spotted owls. Under the provisions of this HCP, surveys are not required for northern spotted owls.

Habitat Suitability

This sale does not contain potential habitat for marbled murrelets. However, there is potential habitat adjacent to the sale area.

Survey Results

The Area Biologist has determined that surveys for marbled murrelets are not necessary for this sale. However, one year of surveys for marbled murrelets was conducted in this area. As a result of these surveys, a Marbled Murrelet Management Area was established adjacent to the sale area.

Known T&E Resources

All sale areas are adjacent to unsurveyed potential habitat. In addition, portions of Areas 1, 2 and 3 of this sale are located within 330 feet of a Marbled Murrelet Management Area.

Operational Considerations

Seasonal operating restrictions will be in effect for all sale areas from April 1 through September 15, annually. Operations may be allowed from 2 hours after sunrise until 2 hours before sunset from August 6 through September 15, annually.

Future Survey Plans

There are no future survey plans for this sale.
