Habitat Suitability

This sale contains suitable habitat for northern spotted owls. It does not contain potential habitat for marbled murrelets.

Survey Results

This sale was surveyed for northern spotted owls in 2002 and 2003, using a protocol endorsed by the U.S. Fish and Wildlife Service¹. There was one observation of a northern spotted owl within 1.5 miles of the sale area. There were no responses on follow-up surveys, and this observation was attributed to a non-territorial single (i.e. "floater") owl.

Due to the absence of potential habitat, surveys for marbled murrelets are not necessary for this sale.

Known T&E Resources

There are no known northern spotted owl activity centers within 1.5 miles or Marbled Murrelet Management Areas within 0.25 miles of this sale.

Operational Considerations

Northern spotted owl survey results are valid until March 15, 2006. All timber should be felled prior to this date.

Future Survey Plans

ODF has no plans for further survey of this sale. However, ODF has an active survey program; northern spotted owl surveys will be conducted within 3 miles, and marbled murrelet surveys within 0.25 miles, of this sale during the life of the contract.
