HARVEST TYPE: Harvesting 41-year-old timber in 7 sale areas. Approximately 293 acres of modified clearcut and 49 acres of retention cut.

SALE LOCATION: Portions of Sections 30, 31, and 32, T1S, R7W; Sections 25 and 36, T1S, R8W; and Sections 5 and 6, T2S, R7W, W.M., Tillamook County, Oregon.

DIRECTIONS TO TIMBER SALE AREA: Travel 12.5 miles east on Trask River Road from Tillamook to Toll Road. Travel 1.75 miles east on Toll Road to Eagle Hill Road. Travel 0.7 mile north on Eagle Hill Road to the timber sale area, which is on the west (left) side of Eagle Hill Road.

The timber sale areas contain negligible volumes of other logs to be paid for at the prices in Section 1740.

STATEMENT:

The Oregon Department of Forestry (ODF) is engaged in an active threatened and endangered (T&E) species survey program. Surveys, determinations, and management measures are developed and implemented in good faith compliance with federal and state Endangered Species Act (ESA) requirements. Restrictions on operations due to T&E species considerations are included in the prospectus. Purchasers are required to comply with all federal and state laws, including the Endangered Species Act. Purchaser should take steps to be certain that no ESA violations occur. Prospective purchasers of timber sales are reminded that ODF surveying efforts may take place any time during the term of a timber sale contract. As part of the survey program, ODF surveys its lands on a continuing basis for land management, species protection, research, and other reasons. During the contract term, T&E survey work and/or the discovery of a threatened or endangered species within or in the vicinity of a timber sale may affect operations contemplated under the contract. In the event a threatened or endangered species is found within or near this sale, ODF may take steps necessary to protect the interests of the State, including contract alteration, suspension, or termination.

SPECIAL REMARKS:

**SEASONAL RESTRICTIONS APPLY - SEE SECTION 2455.**

- Timber sale acreage was calculated with GIS and digital orthophotos.
- Alder grades are diameter sorts: 2S=12" and greater, 3S=10" and 11", and 4S=8" and 9".
- The first payment for hardwoods shall be paid with the first conifer payment.
- The second payment for hardwoods shall be paid prior to log hauling. See Section 1750.
- The total purchase price for hardwoods shall be paid on or before August 31, 2008.
- Purchaser's use of tailholds on BLM land is subject to Tailhold Permit #314.291087. See Section 2120.

SALE OBJECTIVES:

Removal of Douglas-fir with symptoms of Swiss needle cast and removal of red alder to prepare for planting with mixed conifer species.

Exact locations of features represented by map symbols shall be determined on site and shall depend upon the conditions that exist on site. Activities shall be conducted based upon features determined on site rather than features shown on maps.

### Habitat Suitability

This sale is located within the historic Tillamook burn. By ODF policy northern spotted owl surveys are not required. This sale does not contain potential habitat for marbled murrelets.

### Survey Results

Surveys for northern spotted owls and marbled murrelets are not necessary for this sale.

### Known T&E Resources

There are no northern spotted owl activity centers within 1.5 miles or Marbled Murrelet Management Areas within 0.25 miles of this sale.

### Operational Considerations

There are no seasonal restrictions or felling deadlines associated with northern spotted owls or marbled murrelets for this sale.

### Future Survey Plans

ODF has no plans for further survey of this sale. However, ODF will be conducting spotted owl surveys in the vicinity of this sale, as part of an investigation into the presence or absence of spotted owl use of the Tillamook Burn.
