HARVEST TYPE: This sale is a regeneration harvest of three (3) areas containing 169 net harvest acres of predominately 95- to 136-year-old Douglas-fir saw timber. Four (4) of the acres are 25- to 39-year-old Douglas-fir.

SALE LOCATION: Portions of Sections 4 and 5, T23S, R10W, W.M., Coos County, Oregon.

DIRECTIONS TO TIMBER SALE AREA: From Coos Bay, take Highway 101 25 miles north to Reedsport and proceed east on Highway 38 for 13 miles. Turn south on the Loon Lake County Road for 5 miles until the 7700 Road. Turn southwest and proceed 2.1 miles to the 7000 Road, turn northwest and go 1.3 miles to the 7600 Road. Turn south for approximately 0.8 mile to the Timber Sale Area.

There is no project amortization. ODF will **not** reduce the price of a species to amortize the project work. Instead ODF will credit PURCHASER's timber account in the amount of \$72,609 after the project work is completed and accepted, as described in Section 2630, "Credit for Project Work."

The timber sale areas contain negligible volumes of other logs to be paid for at the prices in Section 1740.

PERFORMANCE SECURITY: 20% of bid value (unknown) or the total value of the project work (\$73,000), whichever is greater. Actual bond amount will be rounded up to an even \$1,000 unit.

**ENDANGERED SPECIES ACT COMPLIANCE STATEMENT:** The Oregon Department of Forestry (ODF) is engaged in an active threatened and endangered (T&E) species survey program. Surveys, determinations, and management measures are developed and implemented in good faith compliance with federal and state Endangered Species Act (ESA) requirements. Restrictions on operations due to T&E species considerations are included in the prospectus. Purchasers are required to comply with all federal and state laws, including the Endangered Species Act. Purchaser should take steps to be certain that no ESA violations occur. Prospective purchasers of timber sales are reminded that ODF surveying efforts may take place any time during the term of a timber sale contract. As part of the survey program, ODF surveys its lands on a continuing basis for land management, species protection, research, and other reasons. During the contract term, T&E survey work and/or the discovery of a threatened or endangered species within or in the vicinity of a timber sale may affect operations contemplated under the contract. In the event a threatened or endangered species is found within or near this sale, ODF may take steps necessary to protect the interests of the State, including contract alteration, suspension, or termination.

**SPECIAL REMARKS:** **SEASONAL RESTRICTIONS APPLY - SEE SECTION 2455.**  
Acreage was determined by electronic digitizing using 2003 digital ortho photography and ArcView GIS software program.  
Snag creation is required (see Section 2335).  
This timber sale area is designed for harvest during the dry season. PURCHASER must comply with the "Winter and Wet Weather Option" (Section 2610) if operations are conducted in the winter.  
Placement of logs into streams is required under Section 2365. See also Exhibit I.

**SALE OBJECTIVES:** The objectives of this timber sale are to provide revenue for the Common School Fund and to create a young age class stand in accordance with the balanced landscape approach in the Elliott State Forest Management Plan.

## Biological Survey Report

### Habitat Conservation Plan Area

This sale is within an area covered by a Habitat Conservation Plan (HCP) approved by the U. S. Fish and Wildlife Service. The Incidental Take Permit (ITP) for the HCP covers northern spotted owls. Under the provisions of this HCP, surveys are not required for northern spotted owls.

### Habitat Suitability

This sale contains potential habitat for marbled murrelets.

### Survey Results

Surveys for marbled murrelets were conducted in 2003 and 2004, using a protocol developed by the Pacific Seabird Group<sup>1</sup>. Murrelets were detected as present in sites 3 and 4 in 2003. However, behaviors indicating occupancy were not observed.

### Known T&E Resources

There are no Marbled Murrelet Management Areas within 0.25 miles of this sale.

### Operational Considerations

Marbled murrelet survey results are valid until April 1, 2010. All timber should be felled by April 1, 2010.

ODF has no plans for further survey of this sale. However, ODF has an active survey program and marbled murrelet surveys will be conducted within 0.25 miles of the sale during the life of the contract.
