HARVEST TYPE: Regeneration harvest of 2 units containing approximately 29 net acres of 112-year-old, mature second-growth and 60-year-old, third-growth Douglas-fir saw timber and a small component of red alder and western hemlock.

SALE LOCATION: The timber sale area is located in portions of Section 13, T24S, R12W, W.M., Coos County, Oregon.

DIRECTIONS TO TIMBER SALE AREA: From Coos Bay, proceed north on Highway 101, turn on North Bay Road and travel 2 miles, then proceed on Larson Way for approximately 3 miles to the 3000 Road, then proceed 5 miles to Project Point E.

There is no project amortization. ODF will **not** reduce the price of a species to amortize the project work. Instead ODF will credit PURCHASER's timber account in the amount of \$40,336 after the project work is completed and accepted, as described in Section 2630, "Credit for Project Work."

The timber sale areas contain negligible volumes of other logs to be paid for at the prices in Section 1740.

PERFORMANCE SECURITY: 20% of bid value (unknown) or the total value of the project work (\$41,000), whichever is greater. Actual bond amount will be rounded up to an even \$1,000 unit.

PROJECTS: Improvement of 1,300 feet of road, construction of 3 landings and 1,800 feet of road, and a stockpile of 1,000 cubic yards of rock.

ENDANGERED SPECIES ACT COMPLIANCE STATEMENT: The Oregon Department of Forestry (ODF) is engaged in an active threatened and endangered (T&E) species survey program. Surveys, determinations, and management measures are developed and implemented in good faith compliance with federal and state Endangered Species Act (ESA) requirements. Restrictions on operations due to T&E species considerations are included in the prospectus. Purchasers are required to comply with all federal and state laws, including the Endangered Species Act. Purchaser should take steps to be certain that no ESA violations occur. Prospective purchasers of timber sales are reminded that ODF surveying efforts may take place any time during the term of a timber sale contract. As part of the survey program, ODF surveys its lands on a continuing basis for land management, species protection, research, and other reasons. During the contract term, T&E survey work and/or the discovery of a threatened or endangered species within or in the vicinity of a timber sale may affect operations contemplated under the contract. In the event a threatened or endangered species is found within or near this sale, ODF may take steps necessary to protect the interests of the State, including contract alteration, suspension, or termination.

- Snag creation is required (Section 2335).
- Purchaser shall comply with the "Winter and Wet Weather" option requirements if operations are conducted in the winter (Section 2610).

SALE OBJECTIVES: The objective of this sale is to create a young-age class stand in accordance with the balanced landscape strategy of the Elliott State Forest Management Plan, and to produce revenue for the Common School Fund.

Exact locations of features represented by map symbols shall be determined on site and shall depend upon the conditions that exist on site. Activities shall be conducted based upon features determined on site rather than features shown on maps.

The undersigned understands that the bid is irrevocable and further agrees that if they fail to qualify under the terms of the contract within the thirty-day period, the bid deposit shall become the property of the Oregon Department of Forestry as liquidated damages. **If the undersigned fails to qualify within the thirty-day period, STATE may disqualify the undersigned from submitting another bid on this timber sale.**

Habitat Conservation Plan Area

This sale is within an area covered by a Habitat Conservation Plan (HCP) approved by the U. S. Fish and Wildlife Service. The Incidental Take Permit (ITP) for the HCP covers northern spotted owls. Under the provisions of this HCP, surveys are not required for northern spotted owls.

Habitat Suitability

This sale contains potential habitat for marbled murrelets.

Survey Results

Surveys for marbled murrelets were conducted in 2005 and 2006, using a protocol developed by the Pacific Seabird Group¹. Surveys for sale Areas I and II resulted in presence detections in 2005 and 2006. However, behaviors indicating occupancy were not observed. A survey of Area III in 2006 resulted in a subcanopy observation indicating occupancy. Additionally, presence detections were reported during both years of survey in Area III.

Known T&E Resources

As a result of subcanopy behavior observed during surveys, a marbled murrelet management Area (MMMA) was established and Area III of the sale was dropped. Sale Areas I and II are within 0.25 miles of two MMMA's and subject to seasonal restrictions as described in Operational Considerations.

Operational Considerations

Seasonal operating restrictions will be in effect from April 1 through September 15, annually for those portions of the sale areas within 330 feet of a Marbled Murrelet Management Area. Operations may be allowed from 2 hours after sunrise until 2 hours before sunset from August 6 through September 15, annually.

Marbled murrelet survey results are valid until April 1, 2012. All timber should be felled by this date.

Future Survey Plans

ODF has no plans for further survey of this sale.
