

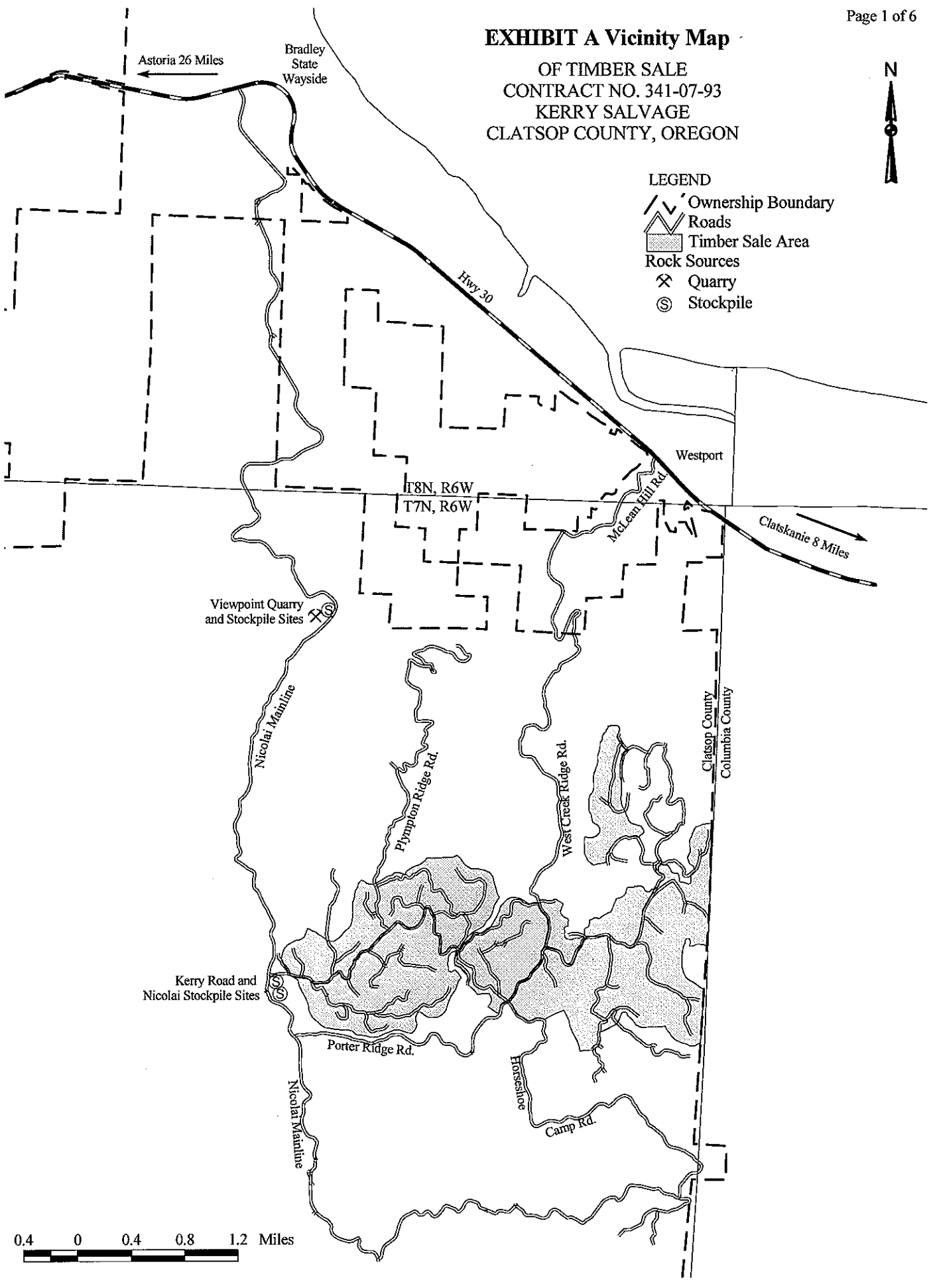
EXHIBIT A Vicinity Map

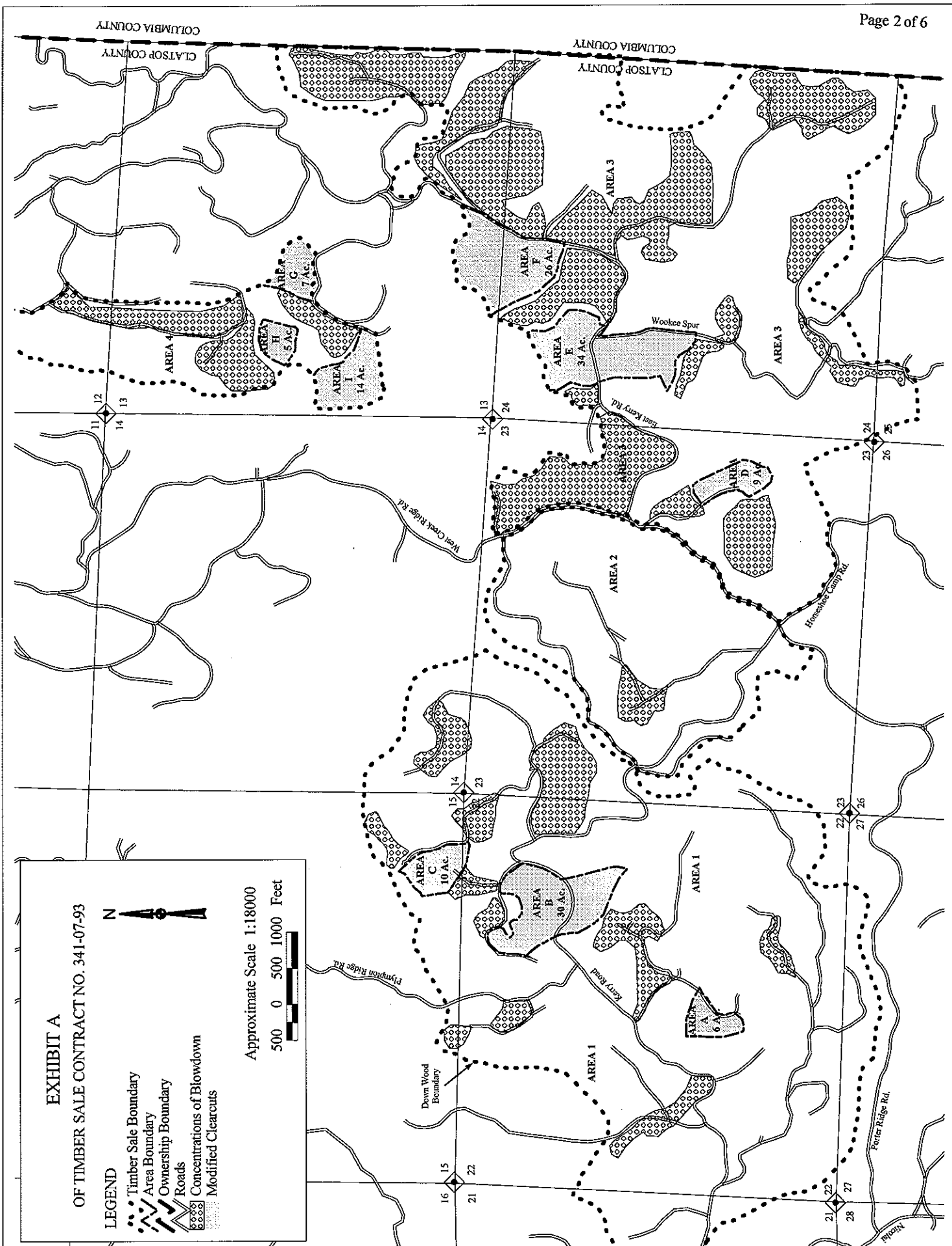

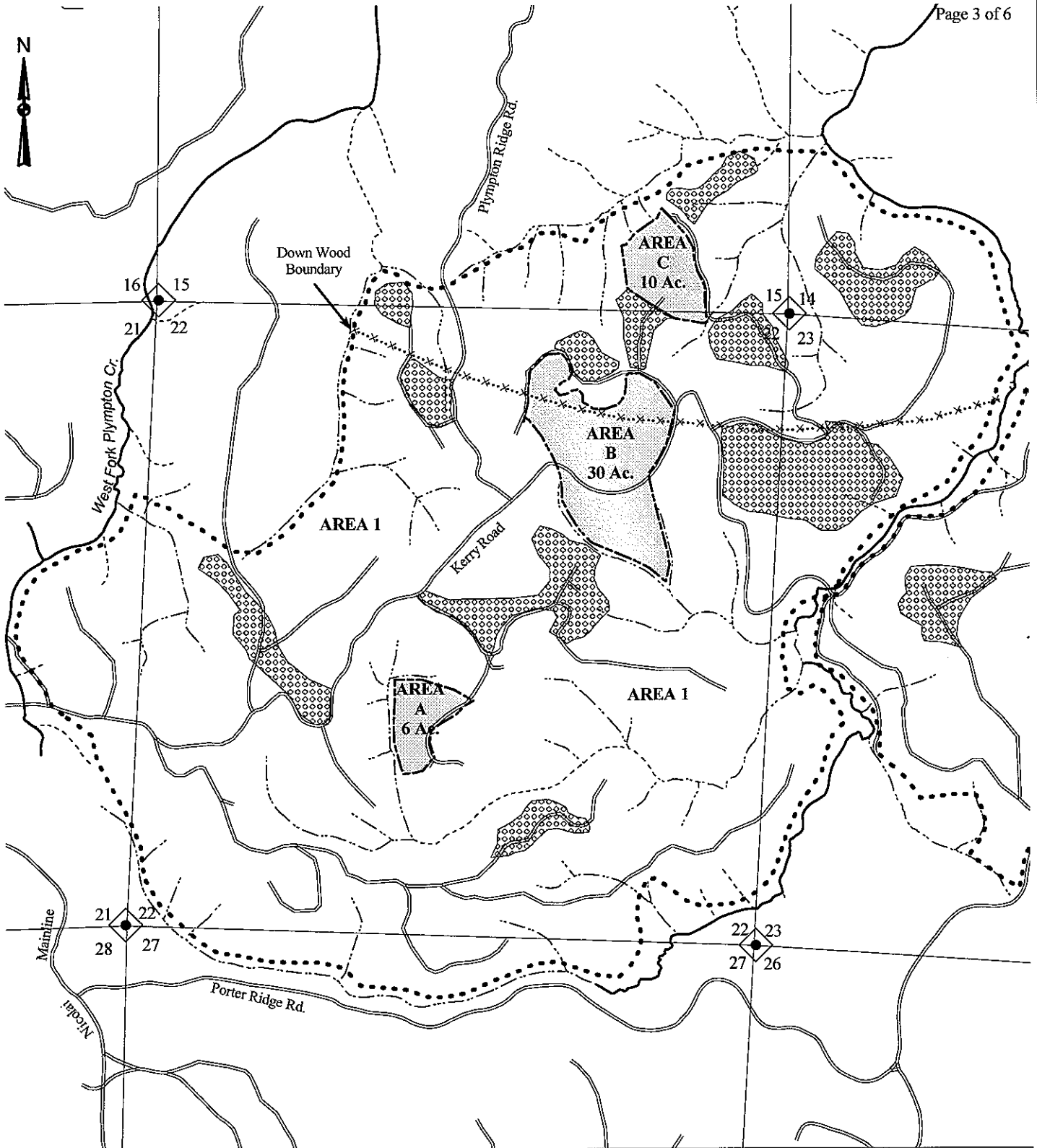
