HARVEST TYPE: Regeneration harvest of two units containing approximately 83 acres of predominantly 104- to 124-year-old, mature second-growth Douglas-fir saw-timber and a small component of red alder, western hemlock, and western redcedar.

SALE LOCATION: The timber sale is located in portions of Section 36, T22S, R11W, W.M., Douglas County, Oregon and portions of Sections 1 and 2, T23S, R11W, W.M., Coos County, Oregon.

DIRECTIONS TO TIMBER SALE AREA: From Coos Bay, travel north on Highway 101 to the town of Lakeside. From Lakeside, proceed on North Lake Drive for approximately 3 miles, where it will become the Benson Ridge Road. Proceed for another mile to Forest Road 4000. Continue on the 4000 Road for about 8 miles to the 2000 Road. Proceed south on the 2000 Road for approximately 1 mile and turn onto the 8000 Road. Continue for approximately 2.5 miles to the 7100 Road. Proceed on the 7100 Road for about 2.25 miles to the 7105 Road. The sale area is approximately 0.5 mile up the 7105 Road.

There is no project amortization. ODF will **not** reduce the price of a species to amortize the project work. Instead ODF will credit PURCHASER's timber account in the amount of \$62,443 after the project work is completed and accepted, as described in Section 2630, "Credit for Project Work."

The timber sale areas contain negligible volumes of other logs to be paid for at the prices in Section 1740.

PERFORMANCE SECURITY: 20% of bid value (unknown) or the total value of the project work (\$63,000), whichever is greater. Actual bond amount will be rounded up to an even \$1,000 unit.

ENDANGERED SPECIES ACT COMPLIANCE STATEMENT: The Oregon Department of Forestry (ODF) is engaged in an active threatened and endangered (T&E) species survey program. Surveys, determinations, and management measures are developed and implemented in good faith compliance with federal and state Endangered Species Act (ESA) requirements. Restrictions on operations due to T&E species considerations are included in the prospectus. Purchasers are required to comply with all federal and state laws, including the Endangered Species Act. Purchaser should take steps to be certain that no ESA violations occur. Prospective purchasers of timber sales are reminded that ODF surveying efforts may take place any time during the term of a timber sale contract. As part of the survey program, ODF surveys its lands on a continuing basis for land management, species protection, research, and other reasons. During the contract term, T&E survey work and/or the discovery of a threatened or endangered species within or in the vicinity of a timber sale may affect operations contemplated under the contract. In the event a threatened or endangered species is found within or near this sale, ODF may take steps necessary to protect the interests of the State, including contract alteration, suspension, or termination.

SPECIAL REMARKS: **SEASONAL RESTRICTIONS APPLY - SEE SECTION 2455.**

Acreage was determined by electronic digitizing using 2003 digital ortho-photography and ArcView GIS software program.

Create 43 snags by topping and girdling trees (Section 2335).

Place fish log structures in Deer Creek where cables cross the buffer as shown on Exhibit I. Volume for log placement is estimated at 36.4 MBF (Section 2350).

The sale area is designed to be logged during the dry season. Purchaser must comply with the "Winter and Wet Weather Option" if operations are conducted in the wet season (Section 2610).

SALE OBJECTIVES: The objectives of this timber sale are to provide revenue for the Common School Fund and to create a young-age class stand in accordance with the Balanced Landscape approach to the Elliott State Forest Management Plan.

The information shown on the Exhibit A map(s) are approximate locations. Exact locations of features represented by map symbols shall be determined on site and shall depend upon the conditions that exist on site. Activities shall be conducted based upon features determined on site rather than features shown on maps.

Habitat Conservation Plan Area

This sale is within an area covered by a Habitat Conservation Plan (HCP) approved by the U. S. Fish and Wildlife Service. The Incidental Take Permit (ITP) for the HCP covers northern spotted owls. Under the provisions of this HCP, surveys are not required for northern spotted owls.

Habitat Suitability

This sale contains potential habitat for marbled murrelets.

Survey Results

Surveys for marbled murrelets were conducted in 2005 and 2006, using a protocol developed by the Pacific Seabird Group¹. Murrelets were detected as present at site 1 on two occasions in 2006 and one occasion at site 2 in 2006. However, behaviors indicating murrelet occupancy were not observed. There were no detections of murrelets at site 3.

Known T&E Resources

The sale is within 0.25 miles of a Marbled Murrelet Management Area.

Operational Considerations

Seasonal operating restrictions will be in effect from April 1 through September 15, annually for all sale areas within 330 feet of suitable habitat within a Marbled Murrelet Management Area. In addition, seasonal operating restrictions will be required within 0.25 miles of a MMMA for the use of explosives associated with road construction. Finally, any overflights must be greater than 500 feet above nesting habitat during the nesting season. Operations may be allowed from 2 hours after sunrise until 2 hours before sunset from August 6 through September 15, annually.

Marbled murrelet survey results are valid until April 1, 2012. All timber should be felled by April 1, 2012.

Future Survey Plans

ODF has no plans for further survey of this sale.
