Habitat Conservation Plan Area

This sale is within an area covered by a Habitat Conservation Plan (HCP) approved by the U. S. Fish and Wildlife Service. The Incidental Take Permit (ITP) for the HCP covers northern spotted owls. Under the provisions of this HCP, surveys are not required for northern spotted owls.

Habitat Suitability

This sale contains potential habitat for marbled murrelets.

Survey Results

Surveys for marbled murrelets were conducted in 2006 and 2007, using a protocol developed by the Pacific Seabird Group¹. Presence detections were observed at site 2 during 2006. Subcanopy observations were reported at sites 1 and 3 during 2006. Presence detections were observed at site 1 in 2007. No detections were observed at sites 2 and 3 in 2007.

Known T&E Resources

As a result of subcanopy behaviors observed during surveys at sites 1 and 3, acreage was added to an existing adjacent Marbled Murrelet Management Area (MMMA).

A portion of this sale is within 0.25 miles of an MMMA.

Operational Considerations

Seasonal operating restrictions will be in effect from April 1 through September 15, annually for sale areas within 330 feet of a Marbled Murrelet Management Area. Operations may be allowed from 2 hours after sunrise until 2 hours before sunset from August 6 through September 15, annually.

Seasonal operating restrictions will be in effect from April 1 through September 15, annually for blasting associated with roadwork within 0.25 miles of a Marbled Murrelet Management Area. Operations will be allowed from 2 hours after sunrise until 2 hours before sunset from August 6 through September 15, annually between points B-C only.

Current marbled murrelet survey results are valid until April 1, 2013. All timber should be felled by April 1, 2013.

Future Survey Plans

Marbled murrelet surveys will be conducted within 0.25 miles of the sale as part of other operations.
