HARVEST TYPE: Regeneration harvest of one unit containing approximately 63 acres of predominately 121- to 128-year-old mature second-growth Douglas-fir saw-timber and a small component of red alder and western hemlock.

SALE LOCATION: The timber sale area is located in portions of Section 14, 15, 22, and 23, T23S, R11W, W.M., Coos County, Oregon.

DIRECTIONS TO TIMBER SALE AREA: From Coos Bay, proceed north on Highway 101 to Lakeside, turn east and follow North Lake Road to the 4000 Road (Benson Ridge). Follow the 4000 Road east to the 4900 and proceed south on the 2000 Road for approximately 2 miles to the 2470. Head east on the 2470 until you are inside the timber sale area.

There is no project amortization. ODF will **not** reduce the price of a species to amortize the project work. Instead ODF will credit PURCHASER's timber account in the amount of \$75,788 after the project work is completed and accepted, as described in Section 2630, "Credit for Project Work."

The timber sale areas contain negligible volumes of other logs to be paid for at the prices in Section 1740.

ENDANGERED SPECIES ACT COMPLIANCE STATEMENT: The Oregon Department of Forestry (ODF) is engaged in an active threatened and endangered (T&E) species survey program. Surveys, determinations, and management measures are developed and implemented in good faith compliance with federal and state Endangered Species Act (ESA) requirements. Restrictions on operations due to T&E species considerations are included in the prospectus. Purchasers are required to comply with all federal and state laws, including the Endangered Species Act. Purchaser should take steps to be certain that no ESA violations occur. Prospective purchasers of timber sales are reminded that ODF surveying efforts may take place any time during the term of a timber sale contract. As part of the survey program, ODF surveys its lands on a continuing basis for land management, species protection, research, and other reasons. During the contract term, T&E survey work and/or the discovery of a threatened or endangered species within or in the vicinity of a timber sale may affect operations contemplated under the contract. In the event a threatened or endangered species is found within or near this sale, ODF may take steps necessary to protect the interests of the State, including contract alteration, suspension, or termination.

Acreage was determined by electronic digitizing using 2005 digital orthophotography and ArcMap 9.2 GIS software program.

Create 32 snags by topping 16 trees and girdling 16 trees (Section 2335).

The sale area is designed to be logged during the dry season. Purchaser must comply with the "Winter and Wet Weather Option" if operations are conducted in the wet season (Section 2610).

Road layouts and logging plans must give priority to scattered green tree retention pods and protection of stream buffers. Logging plans must be approved by STATE before work can begin.

The information shown on the Exhibit A map(s) are approximate locations. Exact locations of features represented by map symbols shall be determined on site and shall depend upon the conditions that exist on site. Activities shall be conducted based upon features determined on site rather than features shown on maps.

Habitat Conservation Plan Area

This sale is within an area covered by a Habitat Conservation Plan (HCP) approved by the U. S. Fish and Wildlife Service. The Incidental Take Permit (ITP) for the HCP covers northern spotted owls. Under the provisions of this HCP, surveys are not required for northern spotted owls.

Habitat Suitability

This sale contains potential habitat for marbled murrelets.

Survey Results

Surveys for marbled murrelets were conducted in 2006 and 2007, using a protocol developed by the Pacific Seabird Group¹. Sub-canopy detections indicating occupancy occurred at a station located within an existing Marbled Murrelet Management Area (MMMA) in 2006. Murrelets were detected as present outside of the MMMA; however, behaviors indicating occupancy were not observed.

Known T&E Resources

This sale is located within 0.25 miles of a Marbled Murrelet Management Area.

Operational Considerations

Seasonal operating restrictions will be in effect from April 1 through September 15, annually for sale areas within 330 feet of a Marbled Murrelet Management Area (MMMA). Operations may be allowed from 2 hours after sunrise until 2 hours before sunset from August 6 through September 15, annually. Landing and road construction or improvement involving blasting, drilling and shooting within 0.25 miles of a MMMA, shall not be allowed at any time from April 1 through September 15.

Current marbled murrelet survey results are valid until April 1, 2013. All timber should be felled by April 1, 2013.

Future Survey Plans

ODF has no plans for further survey of this sale.
