HARVEST TYPE:	This timber sale is a salvage operation of blown down timber located within partial cut stands from the West Green Mountain Combination (341-05-35), Simmons Ridge Combination (341-04-93), Spur 30 SI (341-01-39), and Boyington LSD (341-99-79) timber sales and five stands previously not treated.
	<u>Areas A and T (Salvage)</u> – These stands were not in previous timber sales. Area A is a mixed conifer stand with some alder, and is approximately 50 years old. Area T is a mixed conifer stand heavy to Western Hemlock and Sitka Spruce and is approximately 55 years old. These stands will be harvested in the same manor as Areas B through S and U.
	<u>Areas B through S, and U (Salvage)</u> – These stands were "auto-mark" partial cut two to five years ago, and are approximately 50 to 65 years old, consisting of moderate sized, Western Hemlock, Douglas-fir, and Sitka Spruce with some cedar and alder. Wind storms have significantly damaged portions of these stands, resulting in several large patches and scattered blow-down. These stands will be salvage logged, harvesting only those trees blown down and those that are root sprung (leaning).
	<u>Area 1 (Modified Clearcut)</u> – This stand is a Douglas-fir plantation, approximately 30 years old, with some larger Western Hemlock, Sitka Spruce, and Alder. This area will require whole tree logging and the removal of saw logs.
	<u>Areas 3, 4, and 5 (Modified Clearcut)</u> – These stands have not been harvested previously. They are Western Hemlock, Sitka Spruce and Douglas-fir stands with a mix of Alder and Cedar that are approximately 45 to 70 years old.
	<u>Areas 2, and 6 through 15 (Modified Clearcut)</u> – These stands are similar to Areas A through U. These stands will be logged to salvage downed trees and the anticipated blow-down of the remaining standing trees. These stands range in age from 45 to 70 years old.
	<u>ROADSIDE SALVAGE</u> : All blown down trees and standing trees which are leaning at an angle of 10 degrees or more from vertical located within 100 feet of existing rocked roads located within the timber sale areas.

Habitat Suitability

This sale contains suitable habitat for northern spotted owls in Areas 3, 4, 5, a small portion of Area 6, and Area T only. This sale contains potential habitat for marbled murrelets in Areas 2, 3, 5, 7, F, G, J and T only.

Survey Results

Sale Area T was surveyed for northern spotted owls in 2006 and 2007 as part of other planned operations, using a protocol endorsed by the U.S. Fish and Wildlife Service¹. Northern spotted owls were not observed during these surveys. Surveys will continue in 2008 in this area.

Protocol surveys have not been completed for the remaining sale areas containing suitable habitat. One year of surveys for northern spotted owls was completed in 2007 for sale areas 4 and 5 as part of other planned operations. A second year of protocol surveys will be completed in 2008. Northern spotted owls were not observed during the surveys in 2007. No surveys have been conducted for sale areas 3 and 6. A one-year, 6-visit protocol survey will be conducted in 2008 for these areas.

A survey waiver has been issued for marbled murrelet surveys for Areas 2, 3, 5, 7, F, G, J and T. The probability of occupancy of these stands is believed to be very low due to the openness of the stands resulting from the December 2007 windstorm.

Known T&E Resources

There are no northern spotted owl activity centers within 1.5 miles of this sale. However, since protocol surveys for northern spotted owls have not been completed for sale areas 3, 4, 5 and 6, the status of resident owls in the vicinity is uncertain at this time.

Sale Area 10 is within 0.25 miles of a Marbled Murrelet Management Area (MMMA).

Operational Considerations

Seasonal operating restrictions are not required for sale Area 10 since all operations will be greater than 330 feet from suitable nesting habitat within the MMMA.

In Areas 2, 3, 5, 7, F, G, J and T trees with limbs 5 inches in diameter or larger (platform trees) will be reserved if wind-firm. Trees leaning toward platform trees are also reserved from harvest.

No felling, except for felling associated with project work, shall be allowed in sale Areas 3, 4, 5, 6 and T prior to the completion of the 2008 northern spotted owl surveys indicating no resident spotted owls.

Current northern spotted owl survey results are valid until March 15, 2010 for sale Area T. After the 2008 surveys are completed, the survey results will be valid until March 15, 2011.

Sale areas 4 and 5 will be surveyed for northern spotted owls in 2008 to complete the second year of the survey protocol. After these surveys have been completed the results will be valid until March 15, 2011.

Sale areas 3 and 6 will be surveyed for northern spotted owls using the one year (six visit) methodology in 2008. After these surveys have been completed the results will be valid until March 15, 2009.

All timber in areas 3 and 6 should be felled by March 15, 2009. All timber in areas 4, 5 and T should be felled by March 15, 2011.

Future Survey Plans

ODF will be surveying sale areas 3, 4, 5, 6 and T during 2008 to complete the survey protocol and to extend the contract duration for Area T. In addition, ODF has an active survey program and northern spotted owl surveys will be conducted within 3

miles of this sale during the life of the contract. Also, surveys for marbled murrelets will be conducted within 0.25 miles of some sale areas during the life of the contract.
