This timber sale is a salvage operation of blown-down timber located within partial cut HARVEST TYPE:

stands from the Williamsport Thinning (341-95-19), Mill Creek Combination (341-97-47), and Astoria Basin Thinning (341-04-54) timber sales and portions of two stands

previously not treated.

Areas A and C (Salvage) - Portions of these stands were not in previous timber sales. Area A consists of mixed conifer, mainly Western hemlock and Sitka spruce ranging from 40-84 years old. Area C consists of moderate sized, Western hemlock, Douglas-fir, Sitka spruce, and alder, with traces of cedar. Wind storms have significantly damaged portions of these stands, resulting in several large patches of blown-down timber with few standing trees remaining as well as scattered blow-down. These stands will be salvage logged, harvesting only those trees blown down and those that are root sprung (leaning).

Area B, and Areas D through O (Salvage) - These stands were "auto-mark" partial cut three to twelve years ago, and are approximately 40 to 65 years old, consisting of small and moderate sized Western Hemlock, Douglas-fir, Sitka Spruce, and alder, with traces of cedar. The condition of these stands are similar to Areas A and C and will be salvage logged in the same manner.

Areas 1 and 2 (Modified Clearcut) - These stands are similar to Areas A through O. These stands will be logged to salvage downed trees and the anticipated blow-down of the remaining standing trees. These stands range in age from 40-to 60-years old. These areas will require whole tree logging and the removal of sawlogs and pulp.

Roadside Salvage - All blown-down trees and standing trees which are leaning at an angle of 10 degrees or more from vertical and located within 100 feet of existing rocked roads located within the Timber Sale Areas.

Timber Sale Areas are located in portions of Sections 11, 14, 15, 16, 21, 22, 23, 25,

27, and 28, T8N, R9W, W.M., Clatsop County, Oregon.

Timber Sale Areas can be accessed via Williamsport Forest Road off of Highway 202, approximately 1 mile northwest of the Astoria District Office. Follow the Williamsport Forest Road approximately 0.25 mile from Highway 202 to access Area B. Areas C and D can be accessed via Highway 30 approximately 4.5 miles east of Astoria to Mill Creek Road just past the gate.

For Area E, follow Williamsport Road to Scandinavian Cannery Road for a total of 3.5 miles. Area F can be accessed via an unnamed forest road just due west from the entrance of the Astoria District Office. FELLING RESTRICTIONS: Felling operations in the "Early Felling" portion of Area 1, as shown on Exhibit A, must be completed by March 15, 2009, unless otherwise approved in writing by STATE (Sections 2310, 2350, and 2355).

This sale contains suitable habitat for northern spotted owls in Areas 1 (partial), A, B, C, D, E and F only. This sale contains potential habitat for marbled murrelets in Areas 1, 2, A, B, E, I, J, and O only.

Survey Results

The northeast portion of sale Area 1 and Areas 2, A, B, C (except north portion), D, and E of this sale were surveyed for northern spotted owls in 2005 and 2006, using a protocol endorsed by the U.S. Fish and Wildlife Service¹. Northern spotted owls were not observed during these surveys.

Sale Areas I and J were surveyed for marbled murrelets in 2005 and 2006, using a protocol developed by the Pacific Seabird Group². Murrelets were not detected during these surveys.

A survey waiver for northern spotted owls has been issued for sale Areas A, B, C, D, E and F.

A survey waiver has been issued for marbled murrelets for sale Areas 1, 2, A, B, E, I, J, and O.

Known T&E Resources

There are no northern spotted owl activity centers within 1.5 miles or Marbled Murrelet Management Areas within 0.25 miles of this sale.

There is a great blue heron resource site within ½ mile of sale areas in sections 16 and 21.

There is a bald eagle resource site within ¼ mile of sale areas in section 21.

Operational Considerations

Seasonal operating restrictions will be in effect from February 15 to July 31 for sale areas in sections and 16 and 21 that are within ½ mile of the great blue heron resource site.

Seasonal operating restrictions will be in effect from January 1 to August 31 for sale areas in section 21 within ½ mile of the bald eagle site, unless it can be determined that the nest is not being used during that nesting season.

Per the survey waiver, harvest in areas A, B, C, D, E and F, should be limited to leaning trees and down trees only.

Per the survey waiver, trees with limbs of 5" in diameter or greater and trees leaning towards trees with limbs of 5" in diameter or greater in areas 1, 2, A, B, E, I, J, and O, are reserved from harvest.

Current northern spotted owl survey results for the northeast portion of Area 1 are valid until March 15, 2009. Marbled murrelet survey results for Areas 1 and J are valid until April 1, 2012. All timber in the northeast portion of Area 1 should be felled by March 15, 2009. All timber in the remaining portion of Area 1 and J should be felled by April 1, 2012.

ODF has no plans for further survey of this sale.
