The Oregon Department of Forestry (ODF) is engaged in an active threatened and endangered (T&E) species survey program. Surveys, determinations, and management measures are developed and implemented in good faith compliance with federal and state Endangered Species Act (ESA) requirements. Purchasers are required to comply with all federal and state laws, including the Endangered Species Act. Purchaser should take steps to be certain that no ESA violations occur. Prospective purchasers of timber sales are reminded that ODF surveying efforts may take place any time during the term of a timber sale contract. As part of the survey program, ODF surveys its lands on a continuing basis for land management, species protection, research, and other reasons. During the contract term, T&E survey work and/or the discovery of a threatened or endangered species within or in the vicinity of a timber sale may affect operations contemplated under the contract. In the event a threatened or endangered species is found within or near this sale, ODF may take steps necessary to protect the interests of the State, including contract alteration, suspension, or termination.

NO PERSONAL OR COMPANY CHECKS ACEPTED FOR THIS BID DEPOSIT. SEASONAL RESTRICTIONS APPLY – SEE SECTION 2455.

Acreage was determined by electronic digitizing using 2005 digital orthophotography, 2008 Lidar and ArcMap 9.3 GIS software program.

Spotted Owl density surveys of the Elliott State Forest will be conducted during 2010 (Section 1520).

The 7400 and 7600 Roads are purchaser maintained. Log hauling on these roads may require additional rock as specified by State (Section 2050).

Create 45 snags by topping 23 trees and girdling 22 trees (Section 2335).

A fish log stockpile shall be created consistent with the specifications described in Exhibit I. Volume for the stockpile is estimated at 56 MBF (Section 2350).

All logging equipment used in Ground-Based operations shall be cleaned to prevent the spread of invasive and noxious weeds (Section 2416).

Due to the Marbled Murrelet Management Area (MMMA) adjacent to the timber sale, seasonal restrictions will be in place and haul will be prohibited through the MMMA from April 1 through September 15 annually. In order to complete operations during the summer, a one-day move-in allowance will be in place from August 6 through September 15 with daily timing restrictions to move equipment through the MMMA and into the sale area. To accomplish the move in within the one-day period equipment may need to be staged at the bottom of the 7610 prior to the one-day allowance.

From August 6 until September 15, logging may occur in the sale area while following seasonal restrictions, but log truck traffic will not be allowed through the MMMA. After September 15, seasonal restrictions will be lifted and log truck traffic is permitted through the MMMA (Section 2455).

The sale area is designed to be logged during both the wet and dry seasons. Purchaser must comply with Winter and Wet Weather option if operations on Spurs E to C, B to K, M to N, and M to O are conducted in the wet season (Section 2610).

Road layouts and logging plans must give priority to scattered green tree retention pods and protection of stream buffers. Logging plans must be approved by State before work can begin.

SALE OBJECTIVES:

The objectives of this timber sale are to provide revenue for the Common School Fund and to create a young-age class stand in accordance with balanced landscape approach to the Elliott State Forest Management Plan.

Habitat Conservation Plan Area

This sale is within an area covered by a Habitat Conservation Plan (HCP) approved by the U. S. Fish and Wildlife Service. The Incidental Take Permit (ITP) for the HCP covers northern spotted owls. Under the provisions of this HCP, surveys are not required for northern spotted owls.

Habitat Suitability

This sale contains potentially suitable habitat for marbled murrelets.

Survey Results

Surveys for marbled murrelets were conducted in 2007 and 2008, using a protocol developed by the Pacific Seabird Group¹. There were several observations of marbled murrelets during these surveys, including subcanopy observations indicating occupancy.

Known T&E Resources

As a result of subcanopy behaviors observed during surveys, a Marbled Murrelet Management Area (MMMA) has been established within 0.25 miles of this sale. Additional acreage was added to an existing MMMA greater than 0.25 miles from the sale. Portions of the original planned sale area were incorporated into the MMMA's and removed from the final sale area.

There is a northern spotted owl activity center within 0.25 miles of the sale.

Operational Considerations

Seasonal operating restrictions will be in effect from April 1 through September 15, annually for the sale areas within 330 feet of a Marbled Murrelet Management Area. Operations within the Marbled Murrelet seasonally restricted area may be allowed from 2 hours after sunrise until 2 hours before sunset from August 6 through September 15 annually. A one day move in allowance will be allowed during the period of August 6 through September 15 in order to move equipment through the MMMA provided daily timing restrictions are followed. Log hauling will be prohibited through the Marbled Murrelet Management Area from April 1 through September 15 annually.

Seasonal operating restrictions for the use of explosives will be in effect from April 1 through September 15, annually, for the use of explosives associated with rock quarries in or within 1.0 miles of potential marbled murrelet habitat, and for the use of explosives associated with road construction in or within 0.25 miles of potential marbled murrelet habitat.

Seasonal operating restrictions for the use of large aircraft (including Type 1 helicopters) will be in effect from April 1 through September 15, annually, in or within 0.25 miles of potential marbled murrelet habitat. Seasonal operating restrictions for the use of small aircraft (including single engine airplanes and Type II and III helicopters) will be in effect from April 1 through September 15, annually, in or within 330 feet of potential marbled murrelet habitat. For all aircraft, over-flights must be greater than 500 feet above nesting habitat.

Seasonal operating restrictions for burning within 0.5 mile and for use of explosives within 1.0 mile from March 1 to July 7 are required for portions of the sale area near a nesting pair of northern spotted owls. Seasonal restrictions will be waived if the owls are determined to be non-nesting.

Marbled murrelet survey results are valid until April 1, 2014.

All timber should be felled by April 1, 2014.

Future Survey Plans

ODF has no plans for further survey of this sale. However, ODF will be conducting spotted owl activity center monitoring during the life of the contract. Additionally, spotted owl density surveys of the Elliott State Forest will be conducted during 2010.
