Habitat Suitability

This sale is located in the Sun Pass State Forest, near the edge of the range of the northern spotted owl.

Survey Results

The Sun Pass State Forest was surveyed for northern spotted owls from 1992 -1994, 1999 - 2000, and 2005 - 2006 using standards approved by the U.S. Fish and Wildlife Service. These surveys are done as monitoring surveys under ODF's Eastern Oregon Long-Range Management Plan. There were no responses to any surveys in 1999, 2000, 2005 and 2006.

Known T&E Resources

This sale is not affected by any known northern spotted owl activity centers or bald eagle sites.

Indications of nesting of a non-listed species, the northern goshawk, were found during 2009.

Operational Considerations

This sale is within a Forest Connectivity Area (FCA). Seasonal restrictions apply for operations within a FCA between April 1 and June 30. In the event that nesting goshawks are found within or adjacent to the sale area, seasonal operating restrictions will be extended through August 31 of that year for the area within 1/4 mile of the nest site.

There are no other seasonal restrictions associated with threatened, endangered or sensitive species for this sale.

Future Survey Plans

Northern spotted owl monitoring surveys may be conducted during 2011 and 2012. ODF may conduct northern goshawk surveys in the vicinity of the 2009 observations, annually.
