Habitat Suitability

This sale contains potentially suitable habitat for northern spotted owls and marbled murrelets.

Survey Results

This sale was surveyed for northern spotted owls in 2008 and 2009, using a protocol endorsed by the U.S. Fish and Wildlife Service¹. There was one observation of a northern spotted owl in 2009. Additional visits in 2009 resulted in no further observations of northern spotted owls, and the response from 2009 was determined to be a non-territorial single (or "floater") owl. The Bureau of Land Management (BLM) conducted surveys in the vicinity of the timber sale in 2010. A northern spotted owl was observed on one occasion, and was determined by ODF to be a non-territorial single (or "floater") owl. The BLM will continue to conduct surveys in the vicinity of this timber sale in the future.

Surveys for marbled murrelets were conducted in 2007 and 2008, using a protocol developed by the Pacific Seabird Group². Murrelets were detected as present during one survey in 2010. However, behaviors indicating occupancy were not observed.

Known T&E Resources

There are no northern spotted owl activity centers or Marbled Murrelet Management Areas affecting this sale.

Operational Considerations,

Annual seasonal operating restrictions will be in effect from April 1 through September 15. No project work operations, other than hauling, will be allowed on BLM lands within 2 hours of official sunrise and sunset.

Current northern spotted owl survey results are valid until March 15, 2012. Marbled murrelet survey results are valid until April 1, 2014.

All timber should be felled by March 15, 2012.

Future Survey Plans

ODF has no plans for further survey of this sale. However, ODF has an active survey program and northern spotted owl surveys will be conducted within 3 miles of this sale during the life of the contract. In addition, the Bureau of Land Management will be conducting northern spotted owl surveys within 3 miles of this sale during the life of the contract.
