#### **Habitat Suitability**

This sale contains potentially suitable habitat for northern spotted owls and marbled murrelets.

#### **Survey Results**

This sale was surveyed for northern spotted owls in 2010 and 2011, using a protocol endorsed by the U.S. Fish and Wildlife Service<sup>1,2</sup>. There were three observations of northern spotted owls in 2010. All three observations were attributed to a known activity center within 1.5 miles of the timber sale. There was one observation of an unknown *STRIX* owl during visit 6 in 2011. Follow-up visits were not conducted as it was concluded that if the bird was a northern spotted owl, the detection would have been considered associated with a known activity center within 1.5 miles of the timber sale.

Surveys for marbled murrelets were conducted in 2007 and 2008, using a protocol developed by the Pacific Seabird Group<sup>3</sup>. There were multiple observations of marbled murrelets in 2008, including subcanopy observations indicating occupancy.

#### **Known T&E Resources**

The sale is within 1.5 miles of two northern spotted owl activity centers. A Biological Assessment of the sale's impact on the activity center has been conducted. It concludes the Another Nelson sale, as currently proposed, is expected to have a low risk of negatively affecting the occupancy and productivity of the spotted owl sites.

As a result of subcanopy behaviors observed during surveys in 2008, a Marbled Murrelet Management Area (MMMA) was established. Portions of the timber sale are within 0.25 miles of a MMMA.

#### **Operational Considerations**

Seasonal operating restrictions will be in effect from April 1 through September 15, annually for sale areas within 300 feet of a MMMA. Operations may be allowed from 2 hours after sunrise until 2 hours before sunset from August 6 through September 15, annually.

Current northern spotted owl survey results are valid until March 15, 2014. Marbled murrelet survey results are valid until April 1, 2014.

All timber should be felled by March 15, 2014.

#### **Future Survey Plans**

ODF has no plans for further survey of this sale. However, ODF has an active survey program and northern spotted owl surveys and activity center montoring will be conducted within 3 miles of this sale during the life of the contract.
