Habitat Suitability

This sale contains potentially suitable habitat for northern spotted owls. It does not contain suitable habitat for marbled murrelets.

Survey Results

This sale was surveyed for northern spotted owls in 2009 by an ODF contractor using a protocol endorsed by the U.S. Fish and Wildlife Service¹. There was one observation of a northern spotted owl 2009. This sale was surveyed for northern spotted owls again by an ODF contractor in 2010, using a revised protocol endorsed by the U.S. Fish and Wildlife Service². There was one observation of a northern spotted owl 2010. The observations from 2009 and 2010 were determined to be from a non-territorial single (or "floater") owl. The Bureau of Land Management (BLM) conducted surveys in the vicinity of the timber sale in 2011. A northern spotted owl was observed on two occasions more than 1.5 miles from the 2009 and 2010 observations, and was determined by ODF and ODFW to be a non-territorial single (or "floater") owl likely different than the floater owl from the 2009 and 2010 observations. The BLM is currently conducting surveys in the vicinity of the timber

sale in 2012. To date, a northern spotted owl was observed on 5/15/12 in vicinity of the 2009 and 2010 observations. A preliminary assessment after this 2012 observation has determined that ODF requirements for establishing a resident single site have not been met. The BLM will be conducting additional surveys in 2012 and will continue to conduct surveys in the vicinity of this timber sale in the future.

Surveys for marbled murrelets are not necessary for this sale.

Known T&E Resources

There are no northern spotted owl activity centers or Marbled Murrelet Management Areas affecting this sale.

Operational Considerations,

Current northern spotted owl survey results are valid until March 15, 2013.

All timber should be felled by March 15, 2013.

Future Survey Plans

ODF has no plans for further survey of this sale. However, ODF has an active survey program and northern spotted owl surveys will be conducted within 3 miles of this sale during the life of the contract. In addition, the Bureau of Land Management will be conducting northern spotted owl surveys within 3 miles of this sale during the life of the contract.
