## Survey Results

Surveys for marbled murrelets were conducted in 2011 and 2012, using a protocol developed by the Pacific Seabird Group<sup>1</sup>. Murrelets were not detected during these surveys.

This sale was surveyed for northern spotted owls in 2011 and 2012, using a protocol endorsed by the U.S. Fish and Wildlife Service<sup>2,3</sup>. Northern spotted owls were not observed during these surveys.

There are no northern spotted owl activity centers or Marbled Murrelet Management Areas affecting this sale.

### **Operational Considerations**
