The Oregon Department of Forestry (ODF) is engaged in an active threatened and endangered (T&E) species survey program. Surveys, determinations, and management measures are developed and implemented in good faith compliance with federal and state Endangered Species Act (ESA) requirements. Restrictions on operations due to T&E species considerations are included in the prospectus. Purchasers are required to comply with all federal and state laws, including the Endangered Species Act. Purchaser should take steps to be certain that no ESA violations occur. Prospective purchasers of timber sales are reminded that ODF surveying efforts may take place any time during the term of a timber sale contract. In some cases, ODF may require that initiation of operations be delayed to allow for completion of spot check surveys, as recommended by the USFWS survey protocol and required by ODF policy. As part of the survey program, ODF surveys its lands on a continuing basis for land management, species protection, research, and other reasons. During the contract term, T&E survey work and/or the discovery of a threatened or endangered species within or in the vicinity of a timber sale may affect operations contemplated under the contract. In the event a threatened or endangered species is found within or near this sale. ODF may take steps necessary to protect the interests of the State, including contract alteration, suspension, or termination.

Spotted Owl density surveys of the Elliott State Forest will be conducted during the life of this contract (Section 1520).

Log truck and rock truck traffic, including empties on mile 0.0 to 5.0 of the 1000 Road (Marlow Creek) is not allowed from October 15 through May 15 (Section 2130).

Cable Yarding Operations shall not be allowed from April 1 through September 15 in the Seasonally Restricted Areas shown on Exhibit A (Section 2350).

Cable Yarding Operations shall not be allowed in the "Unsurveyed Mature Timber" areas as shown on the Exhibit A (Section 2350).

If ground-based yarding equipment is selected for harvest operations, Purchaser shall wash equipment associated with ground operations for invasive plants and noxious weeds before operations begin (Section 2416).

The information shown on the Exhibit A map(s) are approximate locations. Exact locations of features represented by map symbols shall be determined on site and shall depend upon the conditions that exist on site. Activities shall be conducted based upon features determined on site rather than features shown on maps.

Habitat Suitability

This sale contains potentially suitable habitat for northern spotted owls. It does not contain suitable habitat for marbled murrelets.

Survey Results

The Elliott State Forest is in a spotted owl density study area The density surveys are conducted using a modified survey approach incorporating aspects of both the density survey protocol (Forsman 1995) and the USFWS-endorsed survey protocol for spotted owls (USFWS 2012)^{1,2}. Northern spotted owls were observed on four occasions in 2011 within 1.5 miles of the timber sale. Three of the observations were attributed to a known activity center within 1.5 miles of the timber sale. One observation was determined to be from non-territorial single (or "floater") owl within 1.5 miles of the timber sale. There were no observations in 2012 and to date in 2013. No observations were made within the timber sale boundary.

Surveys for marbled murrelets are not necessary for this sale.

Known T&E Resources

This sale is within 1.5 miles of a northern spotted owl activity center. A Biological Assessment of the sale's impact on the activity center has been conducted. It concludes the Shake-N-Baker sale, as currently proposed, is expected to have a low risk of negatively affecting the occupancy and productivity of the spotted owl site.

This sale is within 1/4 mile of a Marbled Murrelet Management Area.

Operational Considerations

If felling occurs between March 1 and August 31, 2013 all felling must be completed by March 15, 2015. If no felling occurs between March 1 and August 31, 2013 all felling must be completed by the contract expiration date. Right-of-way felling and project work may proceed within the March 1 through August 31, 2013 timeframe without affecting felling completion dates.

Cable yarding operations shall not be allowed in the unsurveyed mature timber areas. Cable yarding shall not be allowed in the seasonally restricted areas associated with the unsurveyed mature timber from April 1 through September 15, unless otherwise approved by STATE.

Current northern spotted owl survey results are valid until March 15, 2015. If no felling occurs between March 1 and August 31, 2013, spotted owl surveys will be valid until March 15, 2016.

Future Survey Plans

ODF has no plans for further survey of this sale. However, ODF will conduct operational, density, and/or activity center monitoring surveys for northern spotted owls within 3 miles of this sale during the duration of the contract.
