## **Habitat Suitability**

This sale contains potentially suitable habitat for northern spotted owls and marbled murrelets.

## **Survey Results**

This sale was in an area covered by northern spotted owl density surveys in 2012 and 2013. The density surveys were conducted using a modified survey approach incorporating aspects of both the density survey protocol (Forsman 1995) and the USFWS-endorsed survey protocol for spotted owls (USFWS 2012)<sup>1,2</sup>. A northern spotted owl was observed within 1.5 miles of the sale on one occasion during these surveys. This observation was attributed to known activity center within 1.5 miles of the timber sale. In addition to the spotted observation, an unknown *STRIX* species owl was observed within 1.5 miles of the sale on one occasion.

Surveys for marbled murrelets were conducted in 2010 and 2011, using a protocol developed by the Pacific Seabird Group<sup>3</sup>. Marbled murrelets were detected as present at site 1 during two surveys in 2011. Marbled murrelets were detected as present at site 2 during one survey in 2010 and two surveys in 2011. Marbled murrelets were not detected in site 3. Marbled murrelets were detected as present at site 4 during three surveys in 2011. However, behaviors indicating occupancy were not observed at any site.

#### **Known T&E Resources**

The sale is within 1.5 miles of a northern spotted owl activity center. A Biological Assessment of the sale's impact on the activity center has been conducted. It concludes the Salander Between sale, as currently proposed, is expected to have a low risk of negatively affecting the occupancy and productivity of the spotted owl site.

There are no Marbled Murrelet Management Areas affecting this sale.

### **Operational Considerations**

Chainsaw use for tailholds shall not be allowed from April 1, through September 15, annually within the South Umpcoos MMMA or unsurveyed mature habitat. No daily timing restrictions shall be allowed.

Northern spotted owl survey results are valid until March 15, 2016. Marbled murrelet survey results are valid until April 1, 2017.

All timber should be felled by March 15, 2016.

## **Future Survey Plans**

ODF has no plans for further survey of this sale. However, ODF will conduct operational, density, and/or activity center monitoring surveys for northern spotted owls within 3 miles of this sale during the duration of the contract.
