HARVEST TYPE: Area 1 is an 83 acre modified clear-cut of a 65-year-old Douglas-fir stand.  
Area 2 is a 34 acre modified clear-cut of a 70-year-old Douglas-fir stand.  
Area 3 is a 21 acre modified clear-cut of a 70-year-old Douglas-fir stand.

Turn onto Round Top Road and continue for 0.3 mile across the train tracks to the southeast corner of Area 1.

- (e) Understand that falsely entering into this certification is a violation of the Forest Resources Conservation Amendments Act of 1993 and OAR Chapter 629, Division 31, and is subject to any and all penalties contained therein.

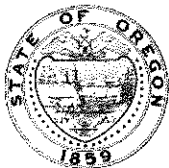

## Revised Biological Survey Report

**Project:** Round House

### Habitat Suitability

This sale contains potentially suitable habitat for northern spotted owls. This sale is located in the Marbled Murrelet Systematic Survey Zone. By ODF policy, operational marbled murrelet surveys are not required.

### Survey Results

This sale was surveyed for northern spotted owls in 2013 and 2014 using a protocol endorsed by the U.S. Fish and Wildlife Service<sup>1,2</sup>. Northern spotted owls were not observed during these surveys. An additional year of surveys is planned for 2015.

Surveys for marbled murrelets are not necessary for this sale.

### Known T&E Resources

There are no northern spotted owl activity centers or Marbled Murrelet Management Areas affecting this sale.

### **Operational Considerations**

No felling, except for felling associated with project work, shall be allowed prior to the completion of the 2015 northern spotted owl surveys indicating no resident spotted owls.

Due to the presence of barred owls, felling restrictions for spotted owl spot check surveys are not required for this sale at this time.

Current northern spotted owl survey results are valid until March 15, 2017. After the 2015 surveys are completed, the survey results will be valid until March 15, 2018.

All timber should be felled by March 15, 2018.

### **Future Survey Plans**

Spotted owl spot check surveys for this timber sale will be required in 2016 and 2017. In addition, ODF has an active survey program and northern spotted owl surveys will be conducted within 3 miles of this sale during the life of the contract.
