The Oregon Department of Forestry (ODF) is engaged in an active threatened and endangered (T&E) species survey program. Surveys, determinations, and management measures are developed and implemented in good faith compliance with federal and state Endangered Species Act (ESA) requirements. Restrictions on operations due to T&E species considerations are included in the prospectus. Purchasers are required to comply with all federal and state laws, including the Endangered Species Act. Purchaser should take steps to be certain that no ESA violations occur. Prospective purchasers of timber sales are reminded that ODF surveying efforts may take place any time during the term of a timber sale contract. As part of the survey program, ODF surveys its lands on a continuing basis for land management, species protection, research, and other reasons. During the contract term, T&E survey work and/or the discovery of a threatened or endangered species within or in the vicinity of a timber sale may affect operations contemplated under the contract. In the event a threatened or endangered species is found within or near this sale. ODF may take steps necessary to protect the interests of the State, including contract alteration, suspension, or termination.

Pulp removal is required if yarded to landing.

Acreage was determined by electronic digitizing using the ArcMap 10.2 GIS program and 2008 Lidar (Light Detection and Ranging) layers.

Spotted owl density surveys of the Elliott State Forest will be conducted during the life of this contract (Section 1520).

Access Permit. PURCHASER's use of the Douglas County Route No. 3 (DCR3) within or adjacent to the timber sale area is subject to a Permit (314.10350), which PURCHASER shall complete with Douglas County. STATE shall provide a sample form and PURCHASER shall furnish a copy of the executed document to STATE within 10 days of its completion. This Permit is required for any activities within the DCR3 Right-of-Way including felling, cable and ground-based yarding, and road construction. Log and rock hauling over DCR3 does not require a permit (Section 2120).

Log truck and rock truck traffic on mile 0.0 to 5.0 of the 1000 Road (Marlow Creek) is not allowed from October 15 through May 15 (Section 2130).

The Purchaser Option Area of approximately three acres as shown on Exhibit A may be excluded from felling if Operations Plan for harvest does not adequately protect the Logging Restricted Areas (Section 2310).

Cable Yarding Operations including stringing of lines and locating tailholds or guy anchors is not allowed at any time in the Logging Restricted Areas or in any Marbled Murrelet Management Area – Occupied Habitat as shown on Exhibit A (Section 2350).

Cable Yarding Operations and non-Project Roads and Landing Construction shall not be allowed from April 1 to August 5 within any Marbled Murrelet Management Area – Buffer. Furthermore, daily timing restrictions shall be in effect from August 6 to September 15 within any Marbled Murrelet Management Area – Buffer during which cable yarding and non-Project Road and Landing Construction may be allowed from no earlier than two hours after sunrise until no later than two hours before sunset (Sections 2350, 2360).

If ground-based yarding equipment is selected for harvest operations, Purchaser shall wash equipment associated with ground operations for invasive plants and noxious weeds before operations begin (Section 2416).

The information shown on the Exhibit A map(s) are approximate locations. Exact locations of features represented by map symbols shall be determined on site and shall depend upon the conditions that exist on site. Activities shall be conducted based upon features determined on site rather than features shown on maps.

Habitat Suitability

This sale contains potentially suitable habitat for northern spotted owls in Areas 1, 4, 5, and 6. This sale does not contain potentially suitable habitat for marbled murrelets.

Survey Results

This sale is in an area covered by northern spotted owl density surveys in 2013 and 2014. The density surveys were conducted using a modified survey approach incorporating aspects of both the density survey protocol (Forsman 1995) and the USFWS-endorsed survey protocol for spotted owls (USFWS 2012)^{1,2}. Northern spotted owls were not observed within 1.5 miles of the timber sale.

Known T&E Resources

There are no northern spotted owl activity centers affecting this sale.

This sale is within ¼ mile of two Marbled Murrelet Management Areas (MMMA).

Operational Considerations

Cable Yarding Operations including the establishment of tailholds, guyline anchors, or stringing of cables shall not be allowed within any Logging Restricted Area or any MMMA.

Cable Yarding Operations shall not be allowed from April 1 through August 5 in any MMMA buffer. Furthermore, daily timing restrictions shall be in effect from August 6 through September 15 within any MMMA buffer during which cable yarding operations may be allowed from no earlier than two hours after sunrise until no later than two hours before sunset.

Non-Project Road and Landing Operations shall not be allowed from April 1 through August 5 within any logging restricted area or MMMA buffer Additionally, daily timing restrictions shall be in effect from August 6 to September 15 within any logging restricted area or MMMA buffer during which Non-Project Road and Landing Operations may be allowed from no earlier than two hours after sunrise until no later than two hours before sunset.

All timber should be felled by March 15, 2017.

Future Survey Plans

ODF plans to continue spotted owl density surveys on the Elliot State Forest in vicinity of this sale. The continuing density survey coverage will be utilized in lieu of the spot check survey requirement. In the future, ODF will conduct density, operational, and/or activity center monitoring surveys for northern spotted owls within 3 miles of this sale during the duration of the contract.
