HARVEST TYPE: Regeneration harvest of approximately 101 acres of 45- to 51-year-old third growth Douglas-fir/western hemlock sawtimber.

SALE LOCATION: The Timber Sale Area is located in portions of Section 32, T23S, R10W, W.M., Coos County, Oregon.

DIRECTIONS TO TIMBER SALE AREA: (All miles approximate). From Coos Bay, take the Coos River Highway 13.7 miles to Allegany. Turn left on Marlow Creek Road (1000 Rd.) and continue for 12.9 miles to Point "A". Walk or ATV for 0.25 mile into Area 1. To access Area 2 continue on the 1000 Road for another 2.0 miles to the 1700 Road. Walk or ATV for 1.2 miles down the 1700 Road to Area 2.

**ENDANGERED SPECIES ACT
COMPLIANCE STATEMENT:**

The Oregon Department of Forestry (ODF) is engaged in an active threatened and endangered (T&E) species survey program. Surveys, determinations, and management measures are developed and implemented in good faith compliance with federal and state Endangered Species Act (ESA) requirements. Restrictions on operations due to T&E species considerations are included in the prospectus. Purchasers are required to comply with all federal and state laws, including the Endangered Species Act. Purchaser should take steps to be certain that no ESA violations occur. Prospective purchasers of timber sales are reminded that ODF surveying efforts may take place any time during the term of a timber sale contract. As part of the survey program, ODF surveys its lands on a continuing basis for land management, species protection, research, and other reasons. During the contract term, T&E survey work and/or the discovery of a threatened or endangered species within or in the vicinity of a timber sale may affect operations contemplated under the contract. In the event a threatened or endangered species is found within or near this sale, ODF may take steps necessary to protect the interests of the State, including contract alteration, suspension, or termination.

SEASONAL RESTRICTIONS APPLY - SEE SECTION 2455.

Acreage was determined by electronic digitizing using 2009 LIDAR imagery and ArcMap 10.2 GIS software program.

Spotted owl density surveys of the Elliott State Forest may be conducted during the life of this contract (Section 1520).

Cable Yarding Operations including locating of tailholds or stringing of cables shall not be allowed within the Logging Restricted Area (Section 2350).

Chain saw use shall not be allowed from April 1 through August 5 within the Chain Saw Restricted Area. Furthermore, daily timing restrictions shall be in effect from August 6 through September 15 within the Chain Saw Restricted Area during which chain saw use may be allowed from no earlier than two hours after sunrise until no later than two hours before sunset (Section 2350).

Pulp removal is required if yarded to Landing.

The information shown on the Exhibit A map(s) are approximate locations. Exact locations of features represented by map symbols shall be determined on site and shall depend upon the conditions that exist on site. Activities shall be conducted based upon features determined on site rather than features shown on maps.

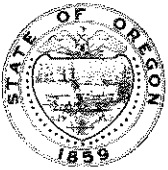
- (a) Are not currently in default status under any timber sale contract sold by the State Forester.

Habitat Suitability

This sale does not contain potentially suitable habitat for northern spotted owls or marbled murrelets.

Survey Results

Surveys for northern spotted owls and marbled murrelets are not necessary for this sale.

Known T&E Resources

There are no northern spotted owl activity centers or Marbled Murrelet Management Areas affecting this sale.

Operational Considerations

There are no early felling dates in regards to T&E surveys.

Seasonal operating restrictions are in effect from April 1 through September 15 for moving dozers adjacent to unsurveyed potentially suitable marbled murrelet habitat along the 1700 road. During the restriction time, dozers that would be used for tailholding on the lower 1700 road may only be walked in no earlier than two hours after sunrise until no later than two hours before sunset.

Future Survey Plans

ODF may conduct density, operational, and/or activity center monitoring surveys for northern spotted owls within 3 miles of this sale during the duration of the contract.
