To access the southern portion of the Timber Sale Area, travel north from Forest Grove on Highway 8 to its junction with Highway 6. Turn left and travel west approximately 3.5 miles to Timber Road. Turn right, proceed north on Timber Road approximately 6.5 miles and turn onto Cochran Road. Continue west on Cochran Road for 2.7 miles to Wheeler Road. Turn right onto Wheeler Road and continue northwest for 3.5 miles to the South Lousignont Road. Turn right and proceed 750 feet to the southwest portion of Area 1. Access to the northern portion of the Timber Sale Area may be obtained by traveling north from Forest Grove on Highway 47 through Banks then merging onto Highway 26 westbound and continuing for approximately 11½ miles to the Timber Road.
