The Oregon Department of Forestry (ODF) is engaged in an active threatened and endangered (T&E) species survey program. Surveys, determinations, and management measures are developed and implemented in good faith compliance with federal and state Endangered Species Act (ESA) requirements. Restrictions on operations due to T&E species considerations are included in the prospectus. Purchasers are required to comply with all federal and state laws, including the Endangered Species Act. Purchaser should take steps to be certain that no ESA violations occur. Prospective purchasers of timber sales are reminded that ODF surveying efforts may take place any time during the term of a timber sale contract. In some cases. ODF may require that initiation of operations be delayed to allow for completion of spot check surveys, as recommended by the USFWS survey protocol and required by ODF policy. As part of the survey program, ODF surveys its lands on a continuing basis for land management, species protection, research, and other reasons. During the contract term, T&E survey work and/or the discovery of a threatened or endangered species within or in the vicinity of a timber sale may affect operations contemplated under the contract. Also, legal challenges and other litigation regarding ODF threatened and endangered species related processes may occur and may affect operations contemplated under the contract. In the event a threatened or endangered species is found within or near this sale, or efforts are required to respond to legal issues, ODF may take steps necessary to protect the interests of the State, including contract alteration, suspension, or termination.

Habitat Suitability

This sale contains potentially suitable habitat for northern spotted owls in areas 1–2. This sale is located in the Marbled Murrelet Systematic Survey Zone. By ODF policy, operational marbled murrelet surveys are not required.

Survey Results

This sale was surveyed for northern spotted owls in 2013 and 2014, using a protocol endorsed by the U.S. Fish and Wildlife Service^{1,2}. Northern spotted owls were observed on two occasions in 2013 and on one occasion in 2014. One of the observations in 2013 and the observation in 2014 was attributed to a known activity center within 1.5 miles of the timber sale. The second observation in 2013 was determined to be a non-territorial single (or "floater") owl greater than 1.5 miles from the timber sale.

To extend the contract duration, an additional year of surveys is being conducted for area 2 in 2015. To date, northern spotted owls were observed on two occasions in

2015. Both of these observations were attributed to a known activity center within 1.5 miles of the timber sale.

Surveys for marbled murrelets are not necessary for this sale.

Known T&E Resources

This sale is within 1.5 miles of a northern spotted owl activity center. A Biological Assessment of the sale's impact on the activity center has been conducted. It concludes that the Microwave Thin timber sale, as currently planned, poses low risk of negatively affecting the northern spotted owl site.

There are no Marbled Murrelet Management Areas affecting this sale.

Operational Considerations

No felling in area 2, except for felling associated with project work, shall be allowed prior to the completion of the 2015 northern spotted owl surveys indicating no resident spotted owls.

If felling operations are not initiated by February 1, felling may not occur until June 30 of each year, or until northern spotted owl spot check surveys are completed, whichever is first. This requirement may be waived by ODF if the delay in initiation of operations is not needed.

Current northern spotted owl survey results are valid until March 15, 2017. After the 2015 surveys are completed in area 2, the survey results for that area will be valid until March 15, 2018.

All timber should be felled by March 15, 2017 in area 1.

All timber should be felled by March 15, 2018 in area 2.

Future Survey Plans

Spotted owl spot check surveys for this timber sale will be required in 2015 and 2016 in area 1. Spotted owl spot check surveys for this timber sale will be required in 2016 and 2017 in area 2.

In addition, ODF has an active northern spotted owl survey program and spot checks, surveys for other planned operations, and activity center monitoring will be conducted within 3 miles of this sale during the life of the contract.
