The Oregon Department of Forestry (ODF) is engaged in an active threatened and endangered (T&E) species survey program. T&E Survey: The sale will be surveyed for Northern Spotted Owl presence during 2017. No timber harvest operations are allowed, other than those associated with Project Work, prior to September 1, 2017 (Felling Sections 2310 and 2455).

Snag Creation (Section 2335).

Directional felling adjacent to OHV trail (Sections 2330 and 2425).

Log Accountability, Section 2015; Log Measurement, Section 2020; Log Branding and Painting, Section 2030; and Exhibit C contain special language for pulp removal.

Log hauling on unsurfaced roads shall not be allowed from November 1 through April 30, unless otherwise approved in writing by STATE (Sections 2130, 2035, and 2455).

Log hauling on North Fork Trask Road is not allowed between November 1 and February 28 (Sections 2130, 2035, and 2455).

Log hauling on North Fork Trask Road is restricted to 4 loads per day between March 1 and October 31 during periods of rain equal to or greater than  $\frac{1}{2}$  inches in a 24-hour period (Sections 2130 and 2035).

Felling must be completed by March 15, 2020 (Sections 2310 and 2455).

## **Habitat Suitability**

This sale contains potentially suitable habitat for northern spotted owls. This sale is located in the Marbled Murrelet Systematic Survey Zone. By ODF policy, operational marbled murrelet surveys are not required.

# **Survey Results**

This sale was surveyed for northern spotted owls in 2015 and 2016. Surveys have been conducted using a protocol endorsed by the U.S. Fish and Wildlife Service<sup>1,2</sup>. Northern spotted owls were not observed in 2015 or 2016. Surveys are ongoing in 2017 to extend the contract felling date.

## **Known T&E Resources**

There are no northern spotted owl activity centers or Marbled Murrelet Management Areas affecting this sale.

# **Operational Considerations**

Due to the presence of barred owls, felling restrictions for spotted owl spot check surveys are not required for this sale at this time.

No felling, except for felling associated with project work, shall be allowed prior to the completion of the 2017 northern spotted owl surveys indicating no resident spotted owls.

Northern spotted owl survey results will be valid until March 15, 2020 upon the completion of 2017 surveys.

All timber should be felled by March 15, 2020.

# **Future Survey Plans**

Spotted owl spot check surveys for this timber sale will be required in 2018 and 2019. In addition, ODF has an active survey program and northern spotted owl surveys may be conducted within 3 miles of this sale during the life of the contract.
