The Oregon Department of Forestry (ODF) is engaged in an active threatened and endangered (T&E) species survey program. Surveys, determinations, and management measures are developed and implemented in good faith compliance with federal and state Endangered Species Act (ESA) requirements. Restrictions on operations due to T&E species considerations are included in the prospectus. Purchasers are required to comply with all federal and state laws, including the Endangered Species Act. Purchaser should take steps to be certain that no ESA violations occur. Prospective purchasers of timber sales are reminded that ODF surveying efforts may take place any time during the term of a timber sale contract. In some cases. ODF may require that initiation of operations be delayed to allow for completion of spot check surveys, as recommended by the USFWS survey protocol and required by ODF policy. As part of the survey program, ODF surveys its lands on a continuing basis for land management, species protection, research, and other reasons. During the contract term, T&E survey work and/or the discovery of a threatened or endangered species within or in the vicinity of a timber sale may affect operations contemplated under the contract. Also, legal challenges and other litigation regarding ODF threatened and endangered species related processes may occur and may affect operations contemplated under the contract. In the event a threatened or endangered species is found within or near this sale, or efforts are required to respond to legal issues, ODF may take steps necessary to protect the interests of the State, including contract alteration, suspension, or termination.

No Felling may occur before September 1, 2016 to allow for completion of T & E surveys (Sections 2310 and 2455) unless otherwise approved in writing by STATE.

Acreage was determined using a combination of GPS and GIS utilizing orthographic imagery and Lidar data.

Firewood sorting is required along surfaced roads and Landings (Section 2365).

PURCHASER shall ensure all ground-based yarding, earth disturbing, road construction, and road maintenance equipment moved onto State Forest land and between State Forest land sites are free of soil, seeds, vegetative matter, or other debris that could contain, or hold, seeds (Section 2416).

62 hours of machine slash piling is required (Section 2560 and Exhibit E).

Access roads for this sale are unsurfaced and will be limited to dry weather use only.

Protect tributary to East Fork Marys River, tributary to Bottger Creek, and Bottger Creek, Type F streams (Section 2415 and FPA Written Plan).

Habitat Suitability

This sale contains potentially suitable habitat for northern spotted owls and marbled murrelets in sale areas 1 and 2.

Survey Results

Sale areas 1 and 2 were surveyed for northern spotted owls in 2014 and 2015 using a protocol endorsed by the U.S. Fish and Wildlife Service^{1,2}. Northern spotted owls were not observed in either 2014 or 2015. Surveys will continue in sale areas 1 and 2 in 2016 to extend the felling date.

Surveys for marbled murrelets were conducted in 2014 and 2015 in sale areas 1 and 2, using a protocol developed by the Pacific Seabird Group³. Marbled murrelets were detected as present

during one survey in 2015 in sale area 2. However, behaviors indicating occupancy were not observed. Marbled murrelets were not detected during surveys in sale area 1.

Known T&E Resources

There are no northern spotted owl activity centers or Marbled Murrelet Management Areas affecting this sale.

Operational Considerations

Due to the presence of barred owls, felling restrictions for spotted owl spot check surveys are not required for this sale at this time.

No felling, except for felling associated with project work, shall be allowed prior to the completion of the 2016 northern spotted owl surveys indicating no resident spotted owls.

Current Northern spotted owl survey results are valid until March 15, 2018.

Upon completion of 2016 northern spotted owl surveys, survey results will be valid until March 15, 2019.

Marbled murrelet survey results are valid until April 1, 2021.

All timber should be felled by March 15, 2019.

Future Survey Plans

Spotted owl spot check surveys for this timber sale will be required in 2017 and 2018. In addition, ODF has an active northern spotted owl survey program and surveys for other planned operations will be conducted within 3 miles of this sale during the life of the contract.
