Habitat Suitability

The operational areas contain potentially suitable habitat for northern spotted owls and marbled murrelets.

Survey Results

The operational areas were for surveyed for northern spotted owls in 2015 and 2016 using a protocol endorsed by the U.S. Fish and Wildlife Service^{1,2}. Two juvenile unknown *Strix* species owls were observed on one visit in 2016. However, northern spotted owls were not observed during these surveys.

Surveys for marbled murrelets were conducted in 2015 and 2016, using a protocol developed by the Pacific Seabird Group³. Marbled murrelets were not observed during these surveys.

Known T&E Resources

There are multiple Marbled Murrelet Management Areas (MMMA) within one mile of operations.

There are no northern spotted owl activity center interactions with planned operations.

Operational Considerations

Seasonal restrictions from April 1 to September 15 are in effect for pile burning within one mile of a MMMA.

Tailholds for sale Area 3 may occur within the buffer of the Boulder Candyflower MMMA with prior Area Biologist consultation.

Due to the presence of barred owls, felling restrictions for spotted owl spot check surveys are not required for operations at this time.

Northern spotted owl survey results are valid until March 15, 2019.

Marbled murrelet survey results are valid until April 1, 2022.

All timber should be felled by March 15, 2019.

Future Survey Plans

Spotted owl spot check surveys for operations will occur in 2017 and 2018. In addition, ODF has an active northern spotted owl survey program and surveys for other planned operations will be conducted within 3 miles of Cougar Looper during the life of the contract.
