ENDANGERED SPECIES ACT COMPLIANCE

STATEMENT:

The Oregon Department of Forestry (ODF) is engaged in an active threatened and endangered (T&E) species survey program. Surveys, determinations, and management measures are developed and implemented in good faith compliance with federal and state

Endangered Species Act (ESA) requirements. Restrictions on operations due to T&E species considerations are included in the prospectus. Purchasers are required to comply with all federal and state laws, including the Endangered Species Act. Purchaser should take steps to be certain that no violations occur. Prospective purchasers of timber sales are reminded that ODF surveying efforts may take place any time during the term of a timber sale contract. In some cases, ODF may require that initiation of operations be delayed to allow for completion of spot check surveys, as recommended by the USFWS survey protocol and required by ODF policy. As part of the survey program, ODF surveys its lands on a continuing basis for land management, species protection, research, and other reasons. During the contract term, T&E survey work and/or the discovery of a threatened or endangered species within or in the vicinity of a timber sale may affect operations contemplated under the contract. Also, legal challenges and other litigation regarding ODF threatened and endangered species related processes may occur and may affect operations contemplated under the contract. In the event a threatened or endangered species is found within or near this sale, or efforts are required to respond to legal issues. ODF may take steps necessary to protect the interests of the State, including contract alteration, suspension, or termination.

# **Habitat Suitability**

This sale contains potentially suitable habitat for northern spotted owls in areas 1 through 4 and marbled murrelets in areas 1 and 4.

# Survey Results

This sale was surveyed for northern spotted owls in various configurations from 2013 to 2017 using a protocol endorsed by the U.S. Fish and Wildlife Service<sup>1,2</sup> This sale was covered by density surveys in 2018<sup>3</sup>. Northern spotted owls were not observed in any year of these surveys.

Surveys for marbled murrelets were conducted in various years from 2016 through 2018. These surveys were conducted using a protocol developed by the Pacific Seabird Group, Marbled murrelets were not detected during these surveys4.

### **Known T&E Resources**

A portion of this sale is within the buffer of a Marbled Murrelet Management Area (MMMA). A Biological Assessment has been conducted. It concludes the risk of incidental take to marbled murrelets is low.

There are no northern spotted owl activity centers areas affecting this sale.

# Operational Considerations

Due to the presence of barred owls, felling restrictions for spotted owl spot check surveys are not required for this sale at this time.

Northern spotted owl survey results will not expire unless density surveys are discontinued. If density surveys are discontinued at any point during the contract, survey coverage will be valid until March 15, three years following the last full season of surveys.

Marbled murrelet survey results are valid until the dates below:

- Areas 1 04/01/2022
- Areas 4 04/01/2023

Seasonal restrictions for sale areas in the vicinity of the Sally Ridge MMMA are required as detailed below:

- Slash pile burning within 0.25 miles of the Sally Ridge MMMA is not allowed from April1 through August 5 each year of the contract.
- Project work involving the use of heavy equipment for road maintenance activities on roads that are not commonly used or within 300 feet of likely nesting habitat (LNH) is restricted between April 1 and August 5, then allowed from August 6 to September 15 with daily timing restrictions each year of the contract.
- Harvest related activities within 300 feet of LNH is restricted between April 1 and August 5, then allowed from August 6 to September 15 with daily timing restrictions each year of the contract.

# **Future Survey Plans**

This sale will be covered by northern spotted owl density surveys during the life of the contract. These density surveys provide incidental survey coverage in lieu of spot checks. If density surveys are not conducted, then spot checks will be required. In addition, ODF has an active northern spotted owl survey program and surveys for other planned operations and density surveys will be conducted within 3 miles of this sale during the life of the contract.
