The Oregon Department of Forestry (ODF) is engaged in an active threatened and endangered (T&E) species survey program. Surveys, determinations, and management measures are developed and implemented in good faith compliance with federal and state Endangered Species Act () requirements. Restrictions on operations due to T&E species considerations are included in the prospectus. Purchasers are required to comply with all federal and state laws, including the Endangered Species Act. Purchaser should take steps to be certain that no violations occur. Prospective purchasers of timber sales are reminded that ODF surveying efforts may take place any time during the term of a timber sale contract. In some cases, ODF may require that initiation of operations be delayed to allow for completion of spot check surveys, as recommended by the USFWS survey protocol and required by ODF policy. As part of the survey program, ODF surveys its lands on a continuing basis for land management, species protection, research, and other reasons. During the contract term, T&E survey work and/or the discovery of a threatened or endangered species within or in the vicinity of a timber sale may affect operations contemplated under the contract. Also, legal challenges and other litigation regarding ODF threatened and endangered species related processes may occur and may affect operations contemplated under the contract. In the event a threatened or endangered species is found within or near this sale, or efforts are required to respond to legal issues, ODF may take steps necessary to protect the interests of the State, including contract alteration, suspension, or termination.

NO PERSONAL OR COMPANY CHECKS ACCEPTED FOR THE BID DEPOSIT. SEASONAL RESTRICTIONS APPLY - SECTION 2455.

Acreage was determined using a combination of GPS and the ODF-GIS system utilizing orthographic imagery and Lidar data.

PURCHASER will need to sign a Temporary Road Use Permit with Weyerhaeuser Corporation for construction and use of a temporary access road (Points K to L) and for hauling on Weyerhaeuser roads. A copy of the Road Use Permit is on file at the Philomath District Office.

PURCHASER shall ensure all ground-based yarding, earth disturbing, road construction, and road maintenance equipment moved onto State Forest Land and between State Forest Land sites are free of soil, seeds, vegetative matter, or other debris that could contain, or hold, seed (Section 2416).

Hauling on Salmon Creek Road is not allowed from December 1 through February 28, except for that portion located between Highway 20 and the Log Truck Turnaround shown on Exhibit A (Section 2455).

Portions of Area 3 are located within the buffer of the Salmon Creek Marbled Murrelet Management Area (MMMA). Consultation with STATE, seasonal restrictions and protection requirements shall apply (Section 2455 and FPA written plan).

Harvest activities in Areas 2 and 3 must be completed by April 1, 2021 (Sections 2310, 2350, and 2355).

Firewood sorting is required along surfaced roads and Landings (Section 2365).

Pulp removal is required if yarded to landing. (Section 2045).

The information shown on the Exhibit A map(s) are approximate locations. Exact locations of features represented by map symbols shall be determined on site and shall depend upon the conditions that exist on site. Activities shall be conducted based upon features determined on site rather than features shown on maps.

Habitat Suitability

This sale contains potentially suitable habitat for marbled murrelets adjacent to sale areas 2 & 3.

This sale does not contain potentially suitable habitat for northern spotted owls.

Survey Results

Surveys for sale areas 2 & 3 were conducted for marbled murrelets in 2014 and 2015, using a protocol developed by the Pacific Seabird Group¹. Marbled murrelets were detected as present during multiple surveys in 2014 in survey sites 1 & 2. However, behaviors indicating occupancy were not observed. Survey sites 3 & 4, had one presence detection in each site in 2014. However, behaviors indicating occupancy were not observed. Survey sites 3 & 4 were dropped from survey in 2015 and incorporated into a Marbled Murrelet Management Area (MMMA).

Surveys for spotted owls are not required.

Known T&E Resources

Sale area 3 lies partially within the non-habitat buffer of a MMMA. Biological Assessment of the sale's impact on the MMMA has been conducted. It concludes that the Little Elk Thin area 3 timber sale, as currently proposed, is expected to have a low risk of incidental take of marbled murrelets.

There are no northern spotted owl activity centers affecting this sale.

Operational Considerations

Marbled murrelet survey results are valid until April 1, 2021.

Felling operations in portions of Area 3 that are within MMMA buffers shall not be allowed from April 1 through August 5 or from August 6 through September 15 between 2 hours before sunset and two hours after sunrise.

Cable Yarding Operations including the use of tailhold/guyline anchors in portions of Area 3 that are within MMMA buffers shall not be allowed from April 1 through August 5 or from August 6 through September 15 between 2 hours before sunset and two hours after sunrise.

Ground-based Operations in portions of Area 3 that are within MMMA buffers shall not be allowed from April 1 through August 5 or from August 6 through September 15 between 2 hours before sunset and two hours after sunrise.

The use of chainsaws in portions of Area 3 that are within MMMA buffers shall not be allowed from April 1 through August 5 or from August 6 through September 15 between two hours before sunset and two hours after sunrise.

Non-Project Road and Landing Operations in portions for Area 3 that are within MMMA buffers shall not be allowed from October 1 through August 5 or from August 6 through September 15 between two hours before sunset and two hours after sunrise.

All harvest activities in Areas 2 & 3 within 100 meters of potentially suitable marbled murrelet habitat should be completed by April 1, 2021.

Future Survey Plans

ODF has an active survey program and northern spotted owl surveys will be conducted within 3 miles of this sale during the life of the contract.
