ENDANGERED SPECIES ACT COMPLIANCE STATEMENT:

The Oregon Department of Forestry (ODF) is engaged in an active threatened and endangered (T&E) species survey program. Surveys, determinations, and management measures are developed and implemented in good faith compliance with federal and state Endangered Species Act () requirements. Restrictions on operations due to T&E species considerations are included in the prospectus. Purchasers are required to comply with all federal and state laws, including the Endangered Species Act. Purchaser should take steps to be certain that no violations occur. Prospective purchasers of timber sales are reminded that ODF surveying efforts may take place any time during the term of a timber sale contract. In some cases, ODF may require that initiation of operations be delayed to allow for completion of spot check surveys, as recommended by the USFWS survey protocol and required by ODF policy. As part of the survey program, ODF surveys its lands on a continuing basis for land management, species protection, research, and other reasons. During the contract term, T&E survey work and/or the discovery of a threatened or endangered species within or in the vicinity of a timber sale may affect operations contemplated under the contract. Also, legal challenges and other litigation regarding ODF threatened and endangered species related processes may occur and may affect operations contemplated under the contract. Habitat Suitability

This sale contains potentially suitable habitat for northern spotted owls in areas 1-4 and marbled murrelets in areas 1 & 2.

Survey Results

All sale areas were covered by spotted owl surveys in 2018¹,² and 2019. Northern spotted owls were not observed in either year of these surveys. Surveys will be conducted in 2020 to extend the contract felling date.

Sale areas 1 & 2 were surveyed for marbled murrelets in 2019, using a protocol developed by the Pacific Seabird Group³. The second year of surveys for areas 1 & 2 will occur in 2020. Marbled murrelets have not been detected in areas 1 & 2 during surveys to date.

Known T&E Resources

There are no Marbled Murrelet Management Areas or Northern Spotted owl sites affecting this sale.

Operational Considerations

Work at Jawrun Pit is not allowed from April 1st through August 5th in any year of the contract. From August 6th through September 15th in any year of the contract, work can only occur between 2 hours after sunrise until 2 hours before sunset.

Work on Waste Area #2 is not allowed from April 1st through August 5th, 2020. From August 6th through September 15th 2020, work can only occur between 2 hours after sunrise until 2 hours before sunset.

Due to the presence of barred owls, felling restrictions for spotted owl spot check surveys are not required for this sale at this time.

No felling, except felling for project work, can be conducted until northern spotted owl surveys have been completed on or before August 31, 2020.

Northern spotted owl survey results for all areas will be valid until March 15, 2023 upon completion of the 2020 surveys.

Marbled murrelet survey results for areas 1 & 2 will be valid until April 1, 2026 upon completion of the 2020 surveys.

All timber should be felled by March 15, 2023.

Future Survey Plans

Spotted owl surveys for all sale areas will occur in 2020. In addition, the second year of marbled murrelet surveys for areas 1 & 2 will occur in 2020. ODF has an active northern spotted owl survey program and surveys for other planned operations and density surveys will be conducted within 3 miles of this sale during the life of the contract.
