HARVEST TYPE: Units 2, 3, & 5: 142 acres of modified clearcut removing approximately 22 MBF/ac of approximately 37 year old Douglas-fir, western hemlock, and red alder.

Units 1, 4, & 6: 622 acres of partial cut, removing approximately 12 MBF/ac of approximately 39 year old Douglas-fir, red alder, and western hemlock.

ENDANGERED SPECIES

STATEMENT:

The Oregon Department of Forestry (ODF) is engaged in an active threatened and endangered (T&E) species survey program. Surveys, determinations, and management measures are developed and implemented in good faith compliance with federal and state Endangered Species Act (ESA) requirements. Restrictions on operations due to T&E species considerations are included in the prospectus. Purchasers are required to comply with all federal and state laws, including the Endangered Species Act. Purchaser should take steps to be certain that no violations occur. Prospective purchasers of timber sales are reminded that ODF surveying efforts may take place any time during the term of a timber sale contract. In some cases, ODF may require that initiation of operations be delayed to allow for completion of spot check surveys, as recommended by the USFWS survey protocol and required by ODF policy. As part of the survey program, ODF surveys its lands on a continuing basis for land management, species protection, research, and other reasons. During the contract term, T&E survey work and/or the discovery of a threatened or endangered species within or in the vicinity of a timber sale may affect operations contemplated under the contract. Also, legal challenges and other litigation regarding ODF threatened and endangered species related processes may occur and may affect operations contemplated under the contract. In the event a threatened or endangered species is found within or near this sale, or efforts are required to respond to legal issues, ODF may take steps necessary to protect the interests of the State, including contract alteration, suspension, or termination.

SEASONAL RESTRICTIONS APPLY - SECTION 2455.**

Approximately 70 Acres of Unit 1 and 5 Acres of Unit 3 have an Early Felling Deadline of April 1, 2023. See Exhibit A for specific locations.

All Pulp yarded to the landing shall be hauled. (Section 2045)

Purchaser shall obtain an ODOT approach permit prior to operations in Unit 1 adjacent to Highway 202 and shall use flaggers to control traffic during operations within 150 feet of the Highway. (Section 2310)

Purchaser may request up to a 1-year extension to an existing ODF sale to allow for the timely completion of salvage operations. Sales that require T&E surveys will require a case-by-case analysis with the Division to ensure extension meets survey requirements. Purchasers can review the Biological Survey Report in their sold sale prospectus to get an idea on extension viability. Interest will not be applied to advertised volume after the original expiration date. All other contractual requirements shall be and will remain in full force and effect.

The information shown on the Exhibit A map(s) are approximate locations. Exact locations of features represented by map symbols shall be determined on site and shall depend upon the conditions that exist on site. Activities shall be conducted based upon features determined on site rather than features shown on maps.

Habitat Suitability

This sale contains potentially suitable habitat for northern spotted owls in all units. Sale units 1, 3, 4, & 7 contain potentially suitable habitat for marbled murrelets.

Survey Results

All sale units have been covered by ongoing density surveys beginning in 2018^{1,2,3}. Northern spotted owls have not been observed during these surveys to date. Density surveys will be ongoing during the life of the sale contract.

Sale units 1, 3, 4, & 7 were surveyed for marbled murrelets in multiple years. These surveys were conducted using a protocol developed by the Pacific Seabird Group⁴. Portions of sale units 1 and 3 were covered with surveys in 2016 and 2017, and 2019

and 2020. Sale units 4 and 7 were covered by surveys in 2019 and 2020. Marbled murrelets were not detected during any year of surveys.

Known T&E Resources

There are no northern spotted owl activity centers or Marbled Murrelet Management Areas affecting this sale.

Operational Considerations

Due to the presence of barred owls, felling restrictions for spotted owl spot check surveys are not required for this sale at this time.

Northern spotted owl survey results will not expire unless density surveys are discontinued. If density surveys are discontinued at any point during the contract, survey coverage will be valid until March 15, three years following the last full season of surveys.

All timber within the Early Felling Areas as depicted in the Exhibit A for Timber Sale Units 1 and 3 should be felled by April 1, 2023.

Timber Sale Units 4 and 7 should be felled by April 1, 2026.

Future Survey Plans

This sale will be covered by northern spotted owl density surveys during the life of the contract. These density surveys provide incidental survey coverage in lieu of spot checks. If density surveys are not conducted, then spot checks will be required. In addition, ODF has an active northern spotted owl survey program and surveys for other planned operations and density surveys will be conducted within 3 miles of this sale during the life of the contract.
