HARVEST TYPE: Units 1, 3, & 4: 227 acres of modified clearcut, removing approx. 29 MBF/acre of 76 year old Douglas-fir, hemlock, red alder, and noble fir.

Unit 2: 89 acres of modified clearcut, removing approx. 47 MBF/acre of 82 year old Douglas-fir, red alder, hemlock, and noble fir.

Unit 5: 84 acres of modified clearcut, removing approx. 76 MBF/acre of 85 year old Douglas-fir, hemlock, and redcedar.

Unit 6 (R/W): 2 acres, removing approx. 47 MBF/acre of timber similar to that in Units 2 and 3.

 SALE AREA: From Astoria, travel South on Highway 202 for approximately 28 miles to Wage Road. Turn South on Wage Road and continue approximately 3.8 miles, crossing Buster Creek Mainline. Continue on Stanley Creek Road for 1.8 miles, turning right at Green Mountain Road. Green Mountain Road enters Unit 2 after approximately 1/2 mile. Units 1, 3, and 4 are accessed by turning from Green Mountain Road onto Military Creek Road (right at the Y). Unit 5 is accessed by continuing on Green Mountain Road (left at the Y), taking the spur to the north next to the Stockpile.

ENDANGERED SPECIES ACT COMPLIANCE STATEMENT: The Oregon Department of Forestry (ODF) is engaged in an active threatened and endangered (T&E) species survey program. Surveys, determinations, and management measures are developed and implemented in good faith compliance with federal and state

Endangered Species Act (ESA) requirements. Restrictions on operations due to T&E species considerations are included in the prospectus. Purchasers are required to comply with all federal and state laws, including the Endangered Species Act. Purchaser should take steps to be certain that no violations occur. Prospective purchasers of timber sales are reminded that ODF surveying efforts may take place any time during the term of a timber sale contract. In some cases, ODF may require that initiation of operations be delayed to allow for completion of spot check surveys, as recommended by the USFWS survey protocol and required by ODF policy. As part of the survey program, ODF surveys its lands on a continuing basis for land management, species protection, research, and other reasons. During the contract term, T&E survey work and/or the discovery of a threatened or endangered species within or in the vicinity of a timber sale may affect operations contemplated under the contract. Also, legal challenges and other litigation regarding ODF threatened and endangered species related processes may occur and may affect operations contemplated under the contract. In the event a threatened or endangered species is found within or near this sale, or efforts are required to respond to legal issues, ODF may take steps necessary to protect the interests of the State, including contract alteration, suspension, or termination.

In Cable Settings, the butt log of every tree greater than 25 inches in diameter (DBH) shall be bucked prior to yarding. (Section 2310)

In Unit 5, PURCHASER shall leave 20 codominant or dominant scattered Cedar trees. All other Cedar in Unit 5 that meets or exceeds the minimum removal specifications in Section 2045, "Log Removal," is Designated Timber. (Section 2310)

All Pulp yarded to the landing shall be hauled. (Section 2045)

Exact locations of features represented by map symbols shall be determined on site and shall depend upon the conditions that exist on site. Activities shall be conducted based upon features determined on site rather than features shown on maps.

Habitat Suitability

This sale contains potentially suitable habitat for northern spotted owls in all areas and marbled murrelets in area 5.

Survey Results

This sale was covered by spotted owl density surveys in 2018^{1,2,3} and 2019. Northern spotted owls were not observed in either year of these surveys. Density surveys will be ongoing during the life of the sale contract.

Sale area 5 was surveyed for marbled murrelets in 2018 and 2019. These surveys were conducted using a protocol developed by the Pacific Seabird Group⁴. Marbled murrelets were not detected during these surveys.

Known T&E Resources

There are no northern spotted owl activity centers or Marbled Murrelet Management Areas affecting this sale.

Operational Considerations

Due to the presence of barred owls, felling restrictions for spotted owl spot check surveys are not required for this sale at this time.

Northern spotted owl survey results will not expire unless density surveys are discontinued. If density surveys are discontinued at any point during the contract, survey coverage will be valid until March 15, three years following the last full season of surveys.

All timber on area 5 should be felled by April 1, 2025.

Future Survey Plans

This sale will be covered by northern spotted owl density surveys during the life of the contract. These density surveys provide incidental survey coverage in lieu of spot checks. If density surveys are not conducted, then spot checks will be required. In addition, ODF has an active northern spotted owl survey program and surveys for other planned operations, activity center monitoring, and density surveys will be conducted within 3 miles of this sale during the life of the contract.
