# Habitat Suitability

This sale contains potentially suitable habitat for northern spotted owls in areas 1-3 and marbled murrelets in areas 1 & 3.

# **Survey Results**

Sale areas 1-3 were covered by spotted owl density surveys in 2018<sup>1,2,3</sup> and 2019. Northern spotted owls were not observed in either year of these surveys. Density surveys will be ongoing during the life of the sale contract.

Sale areas 1 & 3 were surveyed for marbled murrelets in 2018 and 2019, using a protocol developed by the Pacific Seabird Group. Marbled murrelets were not detected during these surveys<sup>4</sup>.

### Known T&E Resources

Project work in quarries are within one mile of a spotted owl activity center and a Marbled Murrelet Management Area Seasonal restriction for blasting apply.

### **Operational Considerations**

Seasonal restrictions are in effect for blasting in the Hamilton Creek Quarry from April 1 through September 15 unless waived by State.

Seasonal restrictions are in effect for blasting in the Buster Creek Quarry from March 1 through July 7 unless waived by State.

Due to the presence of barred owls, felling restrictions for spotted owl spot check surveys are not required for this sale at this time.

Northern spotted owl survey results will not expire unless density surveys are discontinued. If density surveys are discontinued at any point during the contract, survey coverage will be valid until March 15, three years following the last full season of surveys.

Marbled murrelet survey results are valid until April 1, 2025.

All timber must be felled by April 1, 2025.

### Future Survey Plans

This sale will be covered by northern spotted owl density surveys during the life of the contract. These density surveys provide incidental survey coverage in lieu of spot checks. If density surveys are not conducted, then spot checks will be required. In addition, ODF has an active northern spotted owl survey program and surveys for other planned operations and density surveys will be conducted within 3 miles of this sale during the life of the contract.
