HARVEST TYPE: The Timber Sale Area is 100 acres of Modified Clearcut in two stands of stands 65-87 year-old Douglas-fir. Unit 1 is 36 acres and Unit 2 is 64 acres.

LOCATION: Section(s) 5, 6, 8 of T2N R5W W.M., Washington Co., Oregon

DIRECTIONS TO TIMBER SALE AREA: All access to the Timber Sale Area is on surfaced all-weather roads. From Forest Grove, travel north on Highway 8 to its junction with Highway 6. Turn left and travel west approximately 3.5 miles to Timber Road. Turn right, proceed north on Timber Road approximately 6.5 miles, and turn left onto Cochran Road. Continue west on Cochran Road for 3.8 miles to the Round Top Road and turn left. Continue for 1.5 miles on Round Top Road. To access the northern portion of Unit 1, continue an additional 0.8 miles on Round Top Road. To access the northern portion of Unit 2, turn left off of Round Top Road onto Rice Road, and proceed for 1.7 miles.

ENDANGERED SPECIES ACT COMPLIANCE STATEMENT: The Oregon Department of Forestry (ODF) is engaged in an active threatened and endangered (T&E) species survey program. Surveys, determinations, and management measures are developed and implemented in good faith compliance with federal and state Endangered Species Act (ESA) requirements. Restrictions on operations due to T&E species considerations are included in the prospectus. Purchasers are required to comply with all federal and state laws, including the Endangered Species Act. Purchaser should take steps to be certain that no violations occur. Prospective purchasers of timber sales are reminded that ODF surveying efforts may take place any time during the term of a timber sale contract. In some cases, ODF may require that initiation of operations be delayed to allow for completion of spot check surveys, as recommended by the USFWS survey protocol and required by ODF policy. As part of the survey program, ODF surveys its lands on a continuing basis for land management, species protection, research, and other reasons. During the contract term, T&E survey work and/or the discovery of a threatened or endangered species within or in the vicinity of a timber sale may affect operations contemplated under the contract. Also, legal challenges and other litigation regarding ODF threatened and endangered species related processes may occur and may affect operations contemplated under the contract. In the event a threatened or endangered species is found within or near this sale, or efforts are required to respond to legal issues, ODF may take steps necessary to protect the interests of the State, including contract alteration, suspension, or termination.

ODF will modify timber sale contracts to allow purchasers who harvest after HCP permit issuance (expected in 2022) to harvest either (1) under requirements pre HCP to avoid take of listed species or (2) under the new requirements of the HCP, as applicable to each timber sale. If a purchaser chooses to harvest consistent with the requirements of the HCP, it will be the responsibility of the purchaser to comply with the HCP and permits, with assistance from and approval by ODF.

Habitat Suitability

This sale contains potentially suitable habitat for northern spotted owls in all units and potentially suitable habitat for marbled murrelets in unit 2.

Survey Results

This sale has been covered by ongoing density surveys in 2019 and 2020^{1,2,3}. Northern spotted owls have not been observed within 1.5 miles of the sale area during these surveys. Sale unit 2 was surveyed for marbled murrelets in 2019 and 2020, using a protocol developed by the Pacific Seabird Group⁴. Marbled murrelets were not detected during these surveys.

Known T&E Resources

There are no northern spotted owl activity centers or Marbled Murrelet Management Areas affecting this sale.

Operational Considerations

This sale is in a density survey coverage area. Northern spotted owl felling deadlines for survey expirations will not be in effect unless density surveys are discontinued. If density surveys are discontinued at any point during the contract, survey coverage will be valid until March 15, three years following the last full season of surveys.

Marbled murrelet surveys for Unit 2 are valid until April 1, 2026.

All timber in Unit 2 should be felled by April 1, 2026.

Future Survey Plans

This sale will be covered by northern spotted owl density surveys during the life of the contract. These density surveys provide incidental survey coverage in lieu of spot checks. If density surveys are not conducted, then spot checks will be required. In addition, ODF has an active survey program and surveys for other planned operations and northern spotted owl density surveys will be conducted within 3 miles of this sale during the life of the contract. Marbled murrelet surveys will be conducted within ¼ mile of this sale during the life of the contract.
