HARVEST TYPE: The Timber Sale Area is 314 acres of 69 to 83-year-old timber. Unit 1 (PC) is 184 acres, Unit 2 (PC) is 103 acres, Unit 3 (PC-GR) is 6 acres, and Unit 4 (R/W) is 21 acres.

LOCATION: Portions of Section(s) 35, 36 of T3N R7W, Section(s) 1, 2 of T2N R7W W.M., Tillamook Co., Oregon

DIRECTIONS TO TIMBER SALE AREA: All access to the Timber Sale Area is on surfaced all-weather roads. From Forest Grove, travel north on Highway 8 to its junction with Highway 6. Turn left and continue west on Highway 6 for 9.5 miles to Storey Burn Road. Turn right and continue on Storey Burn Road for 5.4 miles to a gate. Continue on Storey Burn Road for 1 mile to Standard Grade Road. Continue on Standard Grade Road for 6.1 miles to Sappington Creek Road. Turn right and continue on Sappington Creek Road 0.3 miles to Point Belding Road. Turn left and continue on Point Belding Road for 0.5 miles to access the southern portion of the Timber Sale Area. There is a gate along this route that will require a key, which can be obtained from the Forest Grove District Office.

The Timber Sale Areas contain negligible volumes of other logs to be paid for at the prices in Section 1740.

ENDANGERED SPECIES ACT COMPLIANCE STATEMENT: The Oregon Department of Forestry (ODF) is engaged in an active threatened and endangered (T&E) species survey program. Surveys, determinations, and management measures are developed and implemented in good faith compliance with federal and state Endangered Species Act (ESA) requirements. Restrictions on operations due to T&E species considerations are included in the prospectus. Purchasers are required to comply with all federal and state laws, including the Endangered Species Act. Purchaser should take steps to be certain that no violations occur. Prospective purchasers of timber sales are reminded that ODF surveying efforts may take place any time during the term of a timber sale contract. In some cases, ODF may require that initiation of operations be delayed to allow for completion of spot check surveys, as recommended by the USFWS survey protocol and required by ODF policy. As part of the survey program, ODF surveys its lands on a continuing basis for land management, species protection, research, and other reasons. During the contract term, T&E survey work and/or the discovery of a threatened or endangered species within or in the vicinity of a timber sale may affect operations contemplated under the contract. Also, legal challenges and other litigation regarding ODF threatened and endangered species related processes may occur and may affect operations contemplated under the contract. In the event a threatened or endangered species is found within or near this sale, or efforts are required to respond to legal issues, ODF may take steps necessary to protect the interests of the State, including contract alteration, suspension, or termination.

ODF will modify timber sale contracts to allow purchasers who harvest after HCP permit issuance (expected in 2022) to harvest either (1) under requirements pre HCP to avoid take of listed species or (2) under the new requirements of the HCP, as applicable to each timber sale. If a purchaser chooses to harvest consistent with the requirements of the HCP, it will be the responsibility of the purchaser to comply with the HCP and permits, with assistance from and approval by ODF.

Pulp removal is not allowed.

Residual Basal Area on each acre shall be at least 150 square feet and not more than 170 square feet for Unit 1 and Unit 2 (Section 2320 (a)).

Total Credits for Project Work Costs have been adjusted on the Project Costs Summary Sheet to add an Additional 10% Fuel Allowance. Fuel Cost Allowance in Appraisal increased from \$3.00/GAL to \$5.00/GAL. Hauling Cost Allowance in Appraisal increased from \$900/DAY to \$1,200/DAY.

Acres were determined using ESRI Arcmap GIS software.

Habitat Suitability

This sale contains potentially suitable habitat for northern spotted owls. This sale does not contain potentially suitable habitat for marbled murrelets.

Survey Results

This sale was covered by northern spotted owl density surveys in 2020 and 2021^{1, 2, 3}. Northern spotted owls have not been observed within 1.5 miles of the sale during these surveys.

Marbled murrelet surveys are not required for this sale.

Known T&E Resources

There are no northern spotted owl activity centers or Marbled Murrelet Management Areas affecting this sale.

Operational Considerations

This sale is in a density survey coverage area. Northern spotted owl felling deadlines for survey expirations will not be in effect unless density surveys are discontinued. If density surveys are discontinued at any point during the contract, survey coverage will be valid until March 15, three years following the last full season of surveys.

Future Survey Plans

This sale will be covered by northern spotted owl density surveys during the life of the contract. These density surveys provide incidental survey coverage in lieu of spot checks. If density surveys are not conducted, then spot checks will be required. In addition, ODF has an active survey program and surveys for other planned operations and northern spotted owl density surveys will be conducted within 3 miles of this sale during the life of the contract.
