Tailholds are not allowed in the "Tailhold Restricted Area" shown on Exhibit A. Tailholds located in the "Non-Harvest-Other" Area shown on Exhibit A, adjacent to Unit 1, require consultation with and approval by STATE prior to use. Seasonal restrictions for chainsaw use also apply in this area (Sections 2350 and 2455).

Acreage was determined using a GIS system utilizing orthographic imagery and Lidar data.

Hauling on Salmon Creek Road is subject to a four loads per day limit from December 1 to March 31 annually (Section 2455).

Due to a Marbled Murrelet survey expiration date, Unit 2 must be completed by March 31, 2025 (Sections 2310, 2350, and 2355).

A key is required for access through the gate shown on Exhibit A and may be checked out at the Philomath office.

Pulp removal is required if yarded to Landing.

Firewood sorting is required along surfaced roads and Landings (Section 2365).

PURCHASER shall ensure all ground-based Yarding, earth disturbing, road construction, and road maintenance equipment moved onto State Forest land and between State Forest land sites are free of soil, seeds, vegetation matter, or other debris that could contain, or hold, seeds.

The information shown on the Exhibit A map(s) are approximate locations. Exact locations of features represented by map symbols shall be determined on site and shall depend upon the conditions that exist on site. Activities shall be conducted based upon features determined on site rather than features shown on maps.

### Habitat Suitability

This sale does not contain potentially suitable habitat for northern spotted owls or marbled murrelets within sale units. There is potentially suitable habitat for marbled murrelets adjacent to Units 1, 2 and 4.

### **Survey Results**

Surveys for northern spotted owls are not required for this sale.

This sale was surveyed for marbled murrelets over multiple years in 2018-2019, 2019-2020 and 2020-2021, using a protocol developed by the Pacific Seabird Group<sup>1</sup>. Marbled murrelets were detected as present during surveys in 2018 and 2019. Behaviors indicating occupancy were not observed.

### Known T&E Resources

There are no northern spotted owl activity centers affecting this sale.

Portions of this sale are near likely occupied marbled murrelet habitat.

### **Operational Considerations**

Marbled murrelet surveys are valid until April 1, 2025 for Unit 2, April 1, 2026 for Unit 1, and April 1, 2027 for Unit 4.

All timber should be felled by April 1, 2025 for Unit 2, April 1, 2026 for Unit 1, and April 1, 2027 for Unit 4.

### Tailhold and Guyline Use Restrictions

- a) Tailholding in the "Tailhold Restriction Area" shown on Exhibit A shall not be allowed.
- b) Tailholding in the "Non-Harvest-Other" Area shown on Exhibit A, adjacent to Unit 1, shall have the following restrictions:
  - The use of chainsaws within the "Non-Harvest-Other" Area, adjacent to Unit 1, shall not be allowed from April 1 through August 5 and from August 6 through September 15 between 2 hours before sunset to 2 hours after sunrise.
  - 2. An ODF Area Biologist or a designee familiar with murrelet habitat and biology will inspect and approve all trees before each is used. Prior notification of at least two weeks for all reviews or meetings with ODF representatives is required. No trees that are considered to be potential habitat or surrounding trees that provide cover to platform trees, as determined by an ODF Area Biologist or designee will be damaged or harvested.

### Future Survey Plans

ODF has an active survey program and surveys for other planned operations and northern spotted owl density surveys will be conducted within 3 miles of this sale during the life of the contract. Marbled murrelet surveys will be conducted within  $\frac{1}{4}$  mile of this sale during the life of the contract.
